Coronavirus Programs

- Individual checks from the IRS
- Paycheck Protection Program (PPP)
- Debt Relief for Existing and New SBA Borrowers (EIDL)
- Employee Retention Tax Credit
- SBA Loans
- Treasury Main Street Loans
- Airline Industry Loans



Individual IRS Checks

- \$1,200 for individual and \$2,400 for married filing jointly and have a work eligible Social Security number with adjusted gross income up to:
 - \$75,000 for individuals
 - \$112,500 for head of household filers and
 - \$150,000 for married couples filing joint returns
- Taxpayers will receive a reduced payment if their AGI is between:
 - \$75,000 and \$99,000 if their filing status was single or married filing separately
 - 112,500 and \$136,500 for head of household
 - \$150,000 and \$198,000 if their filing status was married filing jointly
 - Payment amount is reduced by \$5 for each \$100 above the \$75,000/\$112,500/\$150,000 thresholds
- When?
 - Direct deposit if IRS has your bank account
 - IRS is mailing 5 million per week so last checks should arrive in September
- How do I check Status?

Paycheck Protection Program

- For businesses, 501 (c)3s or veteran organizations, <500 employees. Sole proprietor, independent contractor, self-employed, "gig workers"
- 100% federally guaranteed, loan forgiveness for up to 8 weeks of average payroll and other costs if the business retains employees and their salary levels during that time up to \$100,000, no payments for 6-12 months, after 12 months loan has 4% interest rate, if maintain payroll.
- How can use PPP funds:
 - Payroll
 - Costs related to continuation of group healthcare benefits
 - Interest on mortgage obligations
 - Rent and utilities
 - Interest on debt that existed as of February 15, 2020
 - Refinancing an EIDL loan made between January 31, 2020 and April 3, 2020
- Problems:
 - Approved loans in 2 weeks = 5% of all loans in 2019

Paycheck Protection Program Updates

- \$310 billion replenishment
- "Affiliate" definition continues to exclude VC- and PE-backed companies but gambling companies are now allowed to access PPP
- S-Corps that pay distributions to shareholders are still excluded
- Agricultural producers, farmers and ranchers are now eligible for PPP
- If you filed for a loan based on the PPP Interim Final Rule published on April 2nd no additional action
- Loans still cover vacation, parental, family, medical and sick leave but exclude qualified sick and family leave wages for which the tax credit is used
- Amounts paid to an independent contractor or sole proprietor are excluded from the eligible business's payroll costs
- All payroll costs count toward the \$100,000 annual compensation
- Defense contractors
- Full-time v. part-time employees
- Problems Bank of America, JPMorgan Chase, U.S. Bank and Wells Fargo led PPP program, have preferred issuing bigger loans and those have worked with before, and prioritizing backlog



EIDL, SBA Loans & Debt Relief Updates

- For small businesses, private nonprofits, cooperatives, Employee Stock Ownership Plans, sole proprietorships, independent contractors and tribal businesses in operation by January 31, 2020 and fewer than 500 employees
- \$50 billion for SBA's EIDL Program and \$10 billion for EIDL Grants replenishment
- Loans up to \$1M, 3.75% for for-profit and 2.75% for nonprofit with maximum term of 30 years, collateral is required for loans >\$25,000, loans <\$200,000 don't require a personal guarantee
- Loans may be used to pay for expenses that could have been met if the disaster hadn't happened, including payroll and other operating expenses
- Businesses must submit IRS form 4506 T and a statement of liabilities with the EIDL application
- \$10,000 advance to loan that does NOT need to be repaid, even if loan is denied
- Problems Hard to submit, no way to check status, taking longer than expected
- How to apply and other helpful information:

 - o Affiliation rules apply Control is the key factor for eligibility, many VC backed companies are ineligible, but SBA may issue more lenient regulations https://www.sba.gov/sites/default/files/affiliation_discussion_0.pdf

Tax Credits Updates

- Refundable tax credits can take now continue to be available to employers
- 50% of up to \$10,000 in wages paid by an employer whose business is fully or partially suspended OR gross receipts decline >50% for wages paid after March 13 and before December 31, 2020
- Credit available to ALL employers, regardless of size, including tax exempt organizations EXCEPT: state and local government and small businesses who take SBA loans
- To qualify, the employer must meet one of two tests:
 - Business fully/partially suspended by government order during calendar quarter
 - Gross receipts <50% of comparable quarter in 2019



Main Street Lending Program \$600 billion

- For small and medium-sized businesses that were in good financial condition before the pandemic to maintain payroll and operations
- Eligibility
 - Business up to 15,000 employees OR up to \$5 billion in 2019 revenue (in each case together with affiliates)
 - Formed prior to March 13, 2020
 - Majority of employees based in the US
- Terms
 - 4-year term loans
 - No principal or interest payments for 1 year
 - Minimum loan size: \$500,000 for new and priority loans and \$10 million for increases



Coronavirus Legislation

<u>Updates on Implementation</u>

Health and Human Services Department

- \$75 billion for hospitals, especially in rural area and \$25 billion for additional testing
- Accelerating COVID-19 Therapeutic Interventions and Vaccines (ACTIV) partnership

FEMA

- April 7 to August 8 FEMA no exporting PPE, including filtering facepiece respirators, surgical masks, exam gloves and surgical gloves without approval from FEMA
- \$110 million contract for a week's worth of PPE for more than 15,400 nursing homes

Housing

Homeowners who suspended mortgage payments will not have to make lump sum payments

Education Department

• \$300 million for states to improve virtual education, access to technology for families and expand workforce education.

Labor Department

- Exception for paid leave for costs exceeding businesses' revenues
- Independent contractors and gig workers may qualify for Pandemic Unemployment Assistance

Treasury Department

• Get My Payment - App

Small Business Administration

Private equity and hedge funds can't access PPP



What's Next Issues

- New Congressional Coronavirus Task Force
- Defense Production Act enforcement to increase PPE and testing supply production
- CURES 2.0 proposal
- Healthcare workforce protections
- Hazard pay for essential workers
- More PPP, EIDL and SBA loan funding and individual payments
- Treasury Dept is reconsidering eligibility rules for some businesses (VC/PE-backed)
- Changing threshold of 500,000 people per city for aid
- House Democrats call for 90-Day Suspension of Tariffs on Virus Related Goods
- Infrastructure package
- Loan Cancellation for for-profit students



What's Next Funding

- Funding for workforce training \$15 billion proposal
- Funding for state and local governments \$500 billion \$1 trillion proposal
- Targeted support for nonprofits \$60 billion proposal
- Funding for scientists forced to halt studies due to the pandemic \$26 billion proposal
- Give Students Wi-Fi Devices \$4 Billion proposal

White House:

- WH is planning to suspend small business federal regulations and shutdown borders
- WH "Operation Warp Speed" 100-300 million vaccine doses ready by year's end
- WH partnering with chain retailers to test at least 2% of residents in all 50 states
- Re-opening the economy 14-day periods, increased testing and face masks
- President Trump calls for payroll tax cut or suspension in any upcoming package
- New Apple-Google virus tracing apps released launch in May
- Must pass non-COVID-19 legislation, e.g. FY2021 Appropriations and NDAA
- > Engage your Members of Congress so know your experiences and concerns



Reopening Ohio

- May 1 All health procedures and operations that do not require overnight stay in a hospital can continue to move forward.
- May 4 General offices and manufacturing, distribution and construction companies will be allowed to reopen but must follow guidelines:
 - Require face masks or covering for all employees and clients and customers
 - Conduct daily health assessments of employees and employers
 - Maintain good hygiene, social distancing and hand washing
 - Clean and sanitize workplaces often
 - Maintain social distancing practices of 6-feet between people, use barriers when 6-feet of distance is not possible, establish maximum capacity to 50% of fire code
- May 12 Retail, service and consumer businesses will be allowed to reopen. All
 employees will be required to wear face masks or covering while visiting these
 places of business.
- Remaining closed: K-12 schools, restaurants and bars (carry-out and delivery services permitted), personal appearance/beauty, adult day support or vocational habilitation services in congregate setting, auditoriums, stadiums, arenas, movie theaters, performance theatres, and concert and music halls, public recreation centers and indoor sports facilities, health clubs, fitness centers, residential and day camps, campgrounds



Ohio Coronavirus Resources




Ohio Legislative Update

- **Budget** State needs a balanced budget by June 30.
 - Large surplus going into FY20, now estimated \$2.4B deficit
 - Hope to balance FY20 without \$3B Rainy Day fund
- **Roundtables** Members are holding regional virtual roundtables. Check social media for details
 - G2G organized virtual roundtables with Reps. Stivers, Wenstrup, Joyce, and Gonzalez and Senator Portman and organizing more with Senator Brown and others
- House Update House staff will return on a staggered basis two days a week; scheduled session and committee meetings in May, meeting this week
- Senate Update Senate is working on a plan to safely have staff return to work in the Statehouse; scheduled session and committee in May

Final Tips

- Apply for PPP now as well as SBA Programs
- Regularly check new updates/guidances from Treasury and SBA
- Follow Deadlines and Criteria
- Do registrations in advance before deadlines DUNS, SAM, eBRAP
- Read the BAA/RFP/RPP and respond to each section
- Communicate effectively simplify and use graphics
- Focus on COVID-19 first then explain broader applications for innovation
- Check out reviewers programmatic panel memberships are available on CDMRP website
- Engage your Members of Congress
- Collaborate with the military whenever possible in making submissions and executing research
- Advocate to be included in future COVID-19 legislation
