



Thank you for your inquiry regarding our card scanning services. If you live outside of California, or are unable to visit our location to be fingerprinted, we have a cost effective solution that will save you the time and expense of traveling to one of our California locations.

Our Card Scan Processing Service utilizes advanced scanning technology to convert a traditional Ink Fingerprint Card (FD-258), to an electronic fingerprint record (Live Scan). Converting an Ink Fingerprint Card to an electronic fingerprint record allows an applicant to have their application processed as quickly as if they had travelled to our location.

Attached are the instructions for submitting Ink Fingerprint Cards for conversion to an electronic record, and submission to the California Department of Justice (DOJ) and, if applicable, Federal Bureau of Investigation (FBI).

Completion of Forms:

- Ink Fingerprint Cards (FD-258) can be obtained at any Police or Sheriff’s Department, where you can also be fingerprinted. California Penal Code Section 11102.1 states Individuals residing outside of California applying for employment or certification in California who cannot be fingerprinted in California must have their fingerprints rolled at a law enforcement agency in their state or country of residence. Please include two (2) cards for submission, in case one card is not readable. Be sure to fully fill out the Applicant Information section of the ink card: Date of birth, name, social security number, signature, etc.

If you are unable to obtain 2 FD-258 cards:

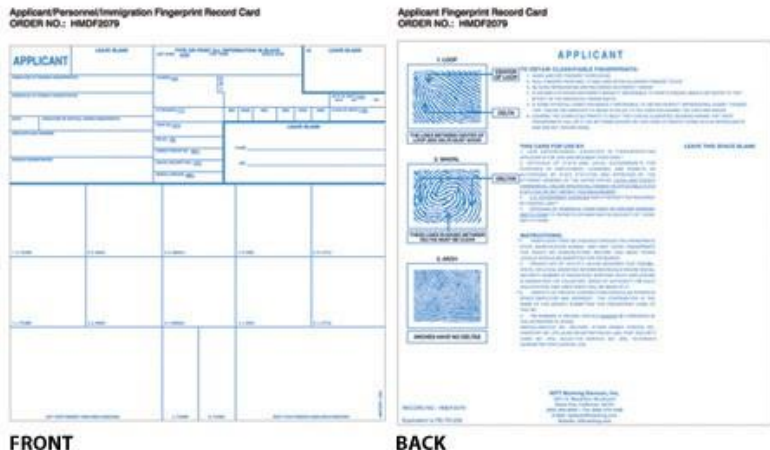
- You will need to obtain a Request for Live Scan form (8016) from the California agency you are applying with. It is essential that you obtain this form. It will be complete with the agency information at the top: ORI, Agency Name/Address, Mail Code and Contact Person, as well as the level of service (DOJ, or DOJ and FBI). You must complete the applicant information section.

Once we receive your fingerprint cards, we will scan, convert and submit your fingerprints to the California DOJ, and if applicable, FBI. We will return two (2) copies of your Request for Live Scan form to you. One is for your records and the other copy should be sent to the requesting agency (the agency you are applying with). DOJ and FBI will complete your criminal background check and forward the results directly to the requesting agency.
