TERMS OF ENROLLMENT

I understand and agree to all of the following Terms of Enrollment:

1. All deposits are fully refundable within 7 days of Enrollment. After 7 days, Camper's family is responsible for full payment of tuition.
2. No refunds or credits will be issued for withdrawals or program changes (including weeks attending) after 7 days from enrollment.
3. Enrolling for additional weeks is always subject to availability. Any weeks added after Camp starts are at the highest weekly rate of the year.
4. There are no refunds or credits due to illness, absence, suspension or emergency closing.
5. Camp reserves the right to terminate this agreement at any time and for any reason with no penalty.
6. All payments are due in full per the payment schedule included on the front of this form.
7. **All Campers must submit a Medical Examination Form signed by a physician AND an on-line Emergency and Medical Profile Information form within 7-days of Enrollment.** No Camper will be permitted to attend Camp without both of these forms and no refunds will be issued. All medical expenses, including deductibles and/or co-pays, are the sole responsibility of Camper's Family and their personal health insurance.
8. Permission is granted for my child to participate in all Camp activities including trips outside of Camp for grades 5-9.
9. Permission is granted to Camp to sign waivers required for Campers to participate in trips outside of Camp for grades 5-9.
10. Camp reserves the right, in its sole discretion, to suspend or dismiss any Camper if his or her conduct is detrimental to the well being of the Camp or of any other Camper(s) and no refunds or credits will be issued.
11. Camp may photograph and video my child and use these images for brochures, websites, promotional, and/or advertising purposes.
12. Camp may use parent's cell phone numbers for text alerts for emergency and/or late return purposes.
13. Camper's family contact information on group lists and other similar formats may be shared with other Camp families solely for the personal use of such families.
14. All Campers must be fully toilet trained prior to attending Camp.
15. All dates are subject to change when school closings are finalized.
16. Any dispute concerning, relating, or referring to this agreement, any representation concerning my child's camping experience, or the camping experience itself shall be resolved exclusively by binding arbitration in Morris County, NJ according to the then existing commercial rules of the American Arbitration Association and the substantive laws of NJ.
