AUDIT FINDINGS

Narrative:

The audit of the North Dakota Adult and Teen Challenge (NDATC) in Mandan, North Dakota was conducted on May 23 and 24, 2019 by Candy Snyder, a Certified PREA auditor and assisted by Mark Snyder, an auditing assistant.

An entrance meeting was held with the Executive Director and PREA Coordinator, Reverend Phil Wolverton, Program Directors Andy Hill and Shannon Sharp. The staff provided the audit team an overview of their program. The audit team outlined the process of the on-site portion of the audit and gathered some basic information to prepare for their time on-site.

The NDATC is a residential, faith-based drug and alcohol treatment recovery program. The program requires a minimum of a 12-month stay to complete treatment. There are four levels through the program, each consisting of a minimum of 12 weeks. Following the four levels, students enter a re-entry period in which staff help the student transition back into their home community.

Family members are encouraged to participate in a student's recovery process. Female students have their children stay with their mothers during an overnight weekend visitation.

The men and women's programs are run completely segregated. Only female staff work in the women's program and only male staff work in the men's program. Each program has their own dining hall and group lectures are held in the chapel that has a divider between the men and women's seating section.

Following the entrance meeting we completed a facility tour. The auditor then began interviewing specialized staff. Private accommodations were made for the auditor to conduct interviews. The Executive Director provided a listing of all residents. There were a total of 32 residents present at the facility. There were no hearing/visually impaired residents, no non-English speaking residents. The auditor was provided a shift roster. We interviewed all staff present on both day and night shifts. The auditor was not limited in any way from speaking with staff or residents or inspecting any area of the facility. All staff were extremely polite and accommodating throughout the audit. In addition the auditor reviewed employment files, training files and investigative files. All confinement facilities within North Dakota are inspected by the North Dakota Department of Corrections and Rehabilitation (NDDOCR) for compliance with NDDOCR standards.

An exit briefing was held with the Executive Director and the Program Managers. The auditor provided a preliminary finding of each standard with the caveat that this was subject to change as the auditor continued to review documents, may have questions to be answered and prepares the interim report. The auditor thanked them for their hard work and their commitment to follow the Prison Rape Elimination Act.

AUDIT FINDINGS

Facility Characteristics:

The auditor's description of the audited facility should include details about the facility type, demographics and size of the inmate or resident population, numbers and type of staff positions, configuration and layout of the facility, numbers of housing units, description of housing units including any special housing units, a description of programs and services, including food service and recreation. The NDATC is a large complex with multiple buildings. Many of the buildings are being leased to external entities. The building primarily used by NDATC is the main, three-story building on the campus. Administrative offices and the woodcraft workshop are located on the first floor. The dining halls, kitchen, chapel, classrooms, library staff offices and the men's living area are located on the 2nd floor. The women's living area is located on the third floor.

The men and women's programs have two pods each. Each pod has four to six sleeping rooms and a community living room with seating and television. The sleeping rooms have up to three residents per room and have a private bathroom consisting of a sink, toilet and shower. The design of all housing areas allows for residents to have privacy for showering, toileting and changing their clothing. In addition, both programs have a weight/recreation area and laundry facilities as well as program staff offices.

The facility is currently undergoing some remodeling of some areas. There have been new cameras added over the last year. The NDATC has a total resident capacity of 65. There are cameras throughout the facility that can be monitored by the executive director within the Administration office or via cell phone or by the program directors either in their office of on cell phone. There are no cameras that can view a shower or toilet area.

Standard 115.215 Limits to cross gender viewing and searches

CORRECTIVE ACTION: Prior to completing the interim report the facility provided cross-gender pat search training to all staff available. The training provided was through the video "Guidance on Cross-Gender and Transgender Pat Searches" produced by the Moss Group Inc. in collaboration with the PREA Resource Center. There were some staff out on extended leave that have not been trained. They will be trained if and when they return to employment. The NDATC provided the auditor copies of the signed and dated training forms.

Standard 115.217 Hiring and promotion decisions

CORRECTIVE ACTION: Prior to completion of the interim audit report the NDATC provided the auditor completed questionnaires for all current employees that had previous institutional employers. This questionnaire is titled "Sexual Misconduct Questionnaire for Previous Institutional Employers". In addition, the NDATC required all staff to complete modified forms that have added the acknowledgement of employees continuing duty to report any sexual misconduct within the facility or within the community. They will ensure that these questions are asked again during the employee's annual review process.

Standard 115.222 Policies to ensure referrals of allegations for investigations

CORRECTIVE ACTION: The auditor required the facility to publish the investigative policy on their website. The facility complied with the standard by publishing their investigative policy on the NDATC website at http://tc4hope.org/about-us/prea

Standard 115.254 Third-party reporting

CORRECTIVE ACTION: The auditor required the NDATC publish the third party reporting information on the facility's website. This information was added to their website at http://www.tc4hope.org/about-us/prea

Standard 115.263 Reporting to other confinement facilities

CORRECTIVE ACTION: The auditor required that the training be strengthened regarding the standard to report any allegation that may have occurred at another facility to be reported to the NDATC Executive Director so that he can report to the head of the facility in which the abuse may have occurred. The Executive Director reiterated this procedure to all staff. The auditor required written documentation of any notices to other facilities regarding reported abuse at their facility. The Executive Director provided a written statement regarding his notification to one facility where abuse allegedly occurred.

Standard 115.266 Preservation of ability to protect residents from contact with abusers CORRECTIVE ACTION: In order to be compliant with this standard the auditor required that the PREA policy be changed to remove the words "non-applicable". The auditor suggested that it states the NDATC does not participate in any collective bargaining agreement and that there is nothing that interferes or restricts the disciplinary process or that would prohibit the Executive Director's ability to remove an alleged abuser from contact with students. These changes were made to the policy and the updated policy provided to the auditor for verification.

CORRECTIVE ACTION: Prior to the interim report being completed the NDATC provided the form in which they will notify the student of the outcome. The form is titled "Report of Investigative Outcome to Resident" and requires a student signature and date. The auditor required use of the form be outlined in policy and the words "verbal or written" be changed in policy to reflect this new procedure. These changes were made and the updated policy provided to the auditor for verification.

Auditor Overall Determination: Meets Standard Auditor Discussion The auditor reviewed the NDATC PREA policy, organization chart, verified the staffing levels through the staffing plan, the schedule that was provided and verified through direct observation while on the facility tour. The Executive Director provided the written annually assessed staffing plan. The NDATC has strong, consistent leadership, a good training program, and a positive culture. There have been no deviations from the staffing plan. The auditor was initally concerned with only a male staff on duty during sleeping hours, but the facility does not complete intakes during these hours. The only activity from the female residents during sleeping hours would be some type of emergency situation and the women's Program Director lives on campus and is able to respond in emergency situations.

115.215 Limits to cross-gender viewing and searches

Auditor Overall Determination: Meets Standard

Auditor Discussion

The NDATC prohibits cross gender searches of residents. Only female staff are assigned to supervise female residents and only male staff are assigned to supervise male residents. Both female and male staff are available to conduct new admissions. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for transgender or intersex residents. If the resident's genital status is unknown, it is determined during conversations with the resident, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner. The facility does not conduct cross gender strip or pat down searches. Because of the facility's policy to not search those of the opposite gender, they felt that they did not need to train how to conduct a cross-gender search. The auditor explained that they still need to train in the event of an emergency situation, or if they admit a resident who is transgender or intersex. The facility has policies and procedures and physical construction of housing areas that enable residents to shower, perform bodily functions, and change clothing without nonmedical staff of the opposite gender viewing them in a state of undress.

CORRECTIVE ACTION: Prior to the completing the interim report the facility provided cross-gender pat search training to all staff available for training. The training provided was through the video "Guidance on Cross-Gender and Transgender Pat Searches" produced by the Moss Group Inc. in collaboration with the PREA Resource Center. There were some staff out on extended leave that have not been trained. They will be trained if and when they return to employment. The NADTC provided the auditor copies of the signed and dated training forms.

115.216 Residents with disabilities and residents who are limited English proficient

Admittance to the NDATC is voluntary. While there are other Teen Challenge Centers in the United States that accommodate residents who are hearing or visually impaired or Spanish Speaking, the NDATC has an admittance policy that requires anyone admitted to the facility speaks English and must read at a 5th grade reading level. If a student does not understand the English language, NDATC will refer the student to a program, which can better serve the student's needs. If a literacy problem exists, a staff member will assist the student to ensure that the student comprehends the materials.

The trained facility investigator completes preliminary administrative investigations. The Executive Director/PREA Coordinator and the Men's Program Director both have been trainied as administrative investigators. Prior to the completion of the interim report the Men's Program Director ended employment with the center. Therefore, Executive Director will be responsible for all Administrative Investigations. As soon as any incident is suspected to be criminal the Mandan Police Department is contacted to condcut any criminal investigation. The center has a Memorandum of Understanding with the Mandan Police Department for both investigations and to publish their number as a reporting method. The trained Administrative investigators have completed the North Dakota Department of Corrections and Rehabilitation's course Investigation Sexual Misconduct: Training for Correctional Investigators. The investigative policy was not published on the NDATC website. CORRECTIVE ACTION: The auditor required the facility to publish the investigative policy on their website In order to be compliant with this standard. The training is based on materials provided to them from the North Dakota Department of Corrections and Rehabilitatioan (NDDOCR) training curriculum. That curriculuym is based on materials provided by the PREA Resource Center and Moss Group training attended by DOCR staff. All staff view the video "PREA: What you Need to Know". Most recently the NDATC staff had training regarding their policy on cross-gender searches. They will continue on-going training to continue their progress of deeper understanding. The NDATC provides basic information to a resident during the intake process about their zero tolerance policy and how to report. During the initial intake the resident will receive a copy of the PREA Resident Brochure and this is discussed with the student during the intake process. Admission to the facility is voluntary by the resident. The facility has a policy that all students must speak English and read at a fifth grade reading level. Thereofre, they do no have materials in other languages or for those that are deaf or blind. The NDATC will refer students to a program, which can better serve the student's needs. If a literacy problem or comprehension problem exists, a staff member will assist the student to ensure that the student comprehends the materials.

A video is shown to the residents soon following intake for further comprehensive information. There is readily available information posted throughout the facility that outlines how to report and how to contact external resources for both support and reporting.

Admission to the facility is voluntary by the resident. The facility has a policy that all students must speak English and read at a fifth grade reading level. Therefore, they do no have materials in other languages or for those that are deaf or blind. The NDATC will refer these students to a program, which can better serve the student's needs. If a literacy problem or comprehension problem exists, a staff member will assist the student to ensure that the student comprehends the materials.

The investigator for the NDATC has received specialized training as facility investigator through the North Dakota Department of Corrections and Rehabilitation's course Investigation of Sexual Misconduct: Training for Correctional Investigators. The auditor interviewed the investigator and found him to be well trained. Specialized training included techniques for interviewing sexual abuse victims, proper use of Miranda and Garrity warnings, sexual abuse evidence collection in confinement settings, and the criteria and evidence required to substantiate a case for administrative action or prosecution referral. Criminal investigations are referred to the Mandan Police Department.

The auditor recommends notating this reassessment with a date and comment on the bottom of the original assessment. 115.252 Exhaustion of administrative remedies

Auditor Overall Determination: Meets Standard

Auditor Discussion

The auditor reviewed the PREA policy regarding Resident Grievances and conducted staff and resident interviews. The NDATC does not impose a time limit on when a student may submit a grievance regarding an allegation of sexual abuse. They do not require a studnet to use any informal grievance process, or to otherwise attempt to resolve with staff, an alleged incident of sexual abuse. They ensure that a student who alleges sexual abuse may submit a grievance without submitting it to a staff member who is the subject of the complaint. They issue a final decision on the merits of any portion of a grievance alleging sexual abuse within 90 days of the initial filing of the grievance.

Third parties, including fellow students, staff members, family members, attorneys, and outside advocates, are permitted to assist students in filing requests for grievances relating to allegations of sexual abuse, and are also be permitted to file such requests on behalf of residents. They have established procedures for the filing of an emergency grievance when the student is subject to a substantial risk of imminent sexual abuse.

After receiving an emergency grievance alleging a substantial risk of imminent sexual abuse, the grievance is immediately forwarded to Administrator for immediate corrective action and provides an initial response within 48 hours, and issues a final decision within five calendar days. The initial response and final decision documents their determination whether the student is in substantial risk of imminent sexual abuse and the action taken in response to the emergency grievance. The NDATC may discipline a student for filing a grievance related to alleged sexual abuse only where the Administrator demonstrates that the student filed the grievance in bad faith.

The evaluation and treatment will include follow-up services, treatment plans, and, when necessary, referrals for continued care following their transfer to, or placement in, other facilities, or their release from the center. Victims of sexual abuse are offered tests for sexually transmitted infections and pregnancy as medically appropriate as determined by community health providers. The NDATC policy prohibits inmates with a history and/or criminal history of previously perpetrating sexual abuse to be housed in the center. If the student is still within the facility, the NDATC will ensure a mental health evaluation of resident-on-resident abusers within 60 days of learning of such abuse history and offer treatment within the community when deemed approriate by mental health practioners.

This review will occur within 30 days of the conclusion of the investigation.
