Stud Dog Owner:

The Stud Dog Owner warrants that their dog is current on all vaccinations, worming, flea and tick control. Pictures of the Stud Dog and it's pedigree ranging from three to six generations can be found online at www.BlueDiamondFrenchie.com under the stud's name. Stud owner warrants that the stud dog has been genetically tested for CMR1, HUU, DM, JHC and has been found to either carry zero or one copy, but not two copies for each of the four defects. Copies of all results will be given upon request.

If Breeder is requiring fresh chilled or fresh frozen semen collection from above listed stud dog, Breeder will assume all monetary costs for the procedure (after the \$300 credit, if applicable). This includes but is not limited to collection of sperm, shipment via the most expedient way and artificial insemination of bitch upon arrival. All the same requirements, health tests, and statements of this contract will still apply to both parties.

Breeder will notify Stud Dog Owner as soon as referenced bitch comes into heat, so that arrangements can be made in a timely manner to ship. Breeder warrants that above listed and described bitch has not been introduced to any other males at any times during this current heat. Breeder also guarantees this bitch will not be exposed to any other males after this Breeding upon her return home. All care will be taken by the Breeder to prevent contact until such time as her heat cycle ends.

Stud Service Agreement

Upon validation of this contract Breeder agrees to furnish Stud Dog Owner with the following:

- 1) Copy of Brucellosis test results
- 2) If Breeder leases bitch, lease agreement between bitch and Owner and Breeder
- 3) Copy of ANY/ ALL registration papers
- 4) A three to six generation pedigree
- 5) At least two color photos of the bitch
- 6) The phone number of the Breeder's veterinarian

Stud Service Contract:

The Stud Dog Owner will allow the bitch to be Artificially Inseminated one-time (unless other arrangements have been previously arranged with the Breeder). Breeder will assume all monetary obligations of this breeding including paying stud fee (\$1,000), paying to collect the semen (after the \$300 credit if applicable) and the shipping (based on location). The Artificial Insemination will be performed by breeders choice and at the expense of the Breeder. The breeder agrees to all of the following regarding the litter that results from this breeding:

Breeder warrants that puppies from this breeding will not be sold into or sold by the commercial dog market. This includes but is not limited to pet stores, puppy mills, and mall stores. Failure to ensure this on the part of breeder could result in suit of damages.

The breeder warrants that NO puppies from this breeding will be released to or handed into any shelter, SPCA, Humane Society or rescue organization.

The breeder warrants that ALL puppies will remain in the care of the breeder until they reach at least 8 weeks in age. Breeder warrants the photos at the ages of 1 day old, 4/5 weeks old and 8 weeks old will be taken of all puppies in the litter and sent to the stud dog owner.

Fee:

The stud fee for this breeding is \$1,000 plus collection fee and shipping to be paid on/ before the time of the appointment for collection. Breeder will receive a \$300 credit if and only if, the semen needs to be shipped to a location further than one to two hours from the stud dog owner's current home location. This \$300 credit is only valid for the first collection. If a second attempt is needed, then breeder will assume all monetary obligations of this breeding including paying to collect the semen and the shipping (based on location).

Other than "Refund Option/Guarantee" all stud fees are not refundable.

Stud Service Agreement

Refund Option/Guarantee: It is guaranteed that if there less than two life births, breeder will receive a second stud service free of charge. If there are less than two life births on the second attempt, then a 50% refund minus the \$300 credit (if applicable) will be provided by the stud owner to the breeder within 30 days after notice. If the stud is no longer available this will result in a 50% refund minus the \$300 credit (if applicable).

To receive a 50% refund the bitch owner must notify the Stud Dog Owner of failure to conceive, in writing no more than 50 days following the mating, with written confirmation from a licensed Veterinarian. If the stud dog is no longer available for whatever reason, the Stud Dog Owner reserves the right to offer a different stud to the bitch owner; however, the breeder may accept or deny this request.

Any refund (as noted above) will be given ONLY to the bitch noted in this contract. Should said bitch die or become unable or fail to conceive or carry a litter, or contract a contagious illness such as Brucellosis, etc that could affect the stud dog, the Stud Dog Owner is no longer obligated to offer a service and refund. Breeder will supply Stud Dog Owner with color photographs of all surviving puppies of this litter.

Agreement

Both parties agree that all paperwork required in this document will be supplied to the applicable parties. It is also understood and agreed that the Stud Dog Owner has the right to refuse to breed-listed stud if any paperwork submitted by Breeder does not meet the requirements of the Stud Dog Owner - This will not result in a refund. This includes, but is not limited to health certificates, pedigrees, etc. It is also agreed and understood by both parties that any and all money, paperwork, pictures, or requirements that are not sent in a timely manner or not met, will be considered a breach of this contract and thus, Stud Dog Owner has no obligation to sign the applicable litter registration papers until requirements are met by the breeder, or vice-versa.

UNDERSTANDING THE CONTRACT TERMS

Buyer agrees that he/she has read and understands the terms and conditions of this contract fully. This contract is designed to protect the French Bulldog, the Breeder, and the stud owner of French Bulldog. By signing, all parties agree to all clauses of this contract.
