Purchasers and consignor hereby agree to indemnify and hold DAA/OKC harmless from any claim which may be made against it on account of representations made by the consignor as to the odometer reading or other claim arising from transactions at the auction. **All vehicles left in excess of 45 days will incur a charge of \$10.00 per day and be deemed to be abandoned.** Undersigned dealer agrees to waive all statutory notices. By registering with DAA/OKC, said dealership will be registered with Auction Access, a national database of participating auto auctions. Dealers Auto Auction of OKC, Inc is not affiliated by ownership to any participating auction.

Re: Credit Card Payments

Effective immediately, DAA/OKC will now accept credit cards for Accounts Receivable balances. At this time, we will only accept Visa and MasterCard payments.

For any account balance payment below \$25, there is a \$1.50 processing fee. Balances \$25.01 to \$999.99 will not be charged a processing fee (DAA/OKC will simply absorb the associated fee). Any balance \$1,000 and over will be charged a 5% processing fee.

For those of you who wish to have titles or checks overnighted to you and do not have an account with Federal Express or a similar carrier, we will take your card information to pay those charges. Due to the amount of a package shipping fee, there is a \$1.50 processing fee for all these charges.

The fee for ALL vehicle purchases will be 5%, regardless of the amount of the vehicle price. This will cover our additional costs for processing the payment. GSA vehicles are processed through the GSA credit card website and do not carry the DAA/OKC processing charge just as in the past.

As a note, our credit card machine is located in our Accounting Department, so we must have your card to take upstairs OR you may call the information in to the Accounting for processing.

We hope this will assist customers with their monthly statements and provide a simpler, smoother payment method.

POST SALE INSPECTION PROGRAM

Let us inspect your auction purchase with our Post Sale Inspection Program.

Each eligible vehicle receives a mechanical and visual frame inspection **PRIOR** to the car leaving the auction. Units that are eligible for Arbitration are handled consistent with the Auction's rules and NAAA policies.

Our Post Sale Inspection Warranties are good for 7 or 14 days, or 150 miles, whichever occurs first, and **MUST** be in the same or better condition as when sold. Arbitrable Defects covered by our Ride & Drive policy that were not detected in the inspection are covered.

No repairs will be made on noises that are inherent or typical to a particular vehicle based on make, model, age, or mileage unless deemed "excessive" by the auction.

Exotic vehicles, kit cars, boats, motorcycles, trailers, home-made vehicles, modified vehicles, and vehicles with a salvage, rebuilt, lemon-law, or trade-assist brand titles are **NOT ELIGIBLE** and are sold "AS-IS".

DAA of OKC will, at its discretion, repair or repurchase the unit if discrepancies occur (normal wear and tear **EXCLUDED**).

THE BUYER IS RESPONSIBLE FOR THE PSI FEE REGARDLESS OF VEHICLE PASS OR FAIL.

DAA of OKC PSI program does not relieve the Responsibility of the seller to make proper announcements on a vehicle nor does it affect NAAA's arbitration guidelines for frame damage. Frame is 7 days.
