PRIVACY POLICY

DealTap is founded on the principle of helping agents close deals. We know that you care about how your personal information is used and shared, and we take your privacy very seriously. By visiting the DealTap website, you are accepting the practices outlined in this policy.



WHO WE ARE

This site is operated by DealTap Group Inc. For the purposes of this policy “DealTap” means DealTap Group Inc. and its subsidiaries or affiliates from time to time. DealTap provides an interactive, Internet-based platform that allows its clients to create, edit, negotiate, upload, download, share and sign documents and contracts online in order to digitally facilitate and manage real estate transactions. This privacy policy applies to the practices of DealTap with respect to its use of the information it collects about you online at its website and through the provision of DealTap’s products and services.

SITE USAGE PRIVACY POLICY

DealTap respects the privacy of all visitors to our website and subscribers of our service. We have created this privacy policy (“Policy”) to define the methods we use to specifically protect personally identifiable information submitted to us via our website, email subscription requests, subscription for services, forms and any other electronic method controlled by DealTap.com and subsidiary domains. By providing personal information to DealTap through our website or through the subscription and use of our services, you agree and consent that DealTap may collect, use, and disclose your personal information in accordance with this Policy. You may refuse or withdraw consent at any time, subject to legal and contractual restrictions and reasonable notice. Please note that refusal or withdrawal of consent may prevent DealTap from providing you with our products or services.

WHAT INFORMATION DO WE COLLECT?

We collect information from you when you visit our website, subscribe to our newsletter, respond to a survey, fill out a form or subscribe to and use our services. For the purposes of this Policy “Personal Information” is information about an identifiable individual. The type of personal information collected when subscribing or registering on our website, as appropriate, may include, but is not limited to: name, e-mail address, mailing address, phone number, credit card information and information about a real estate transaction in which you are involved. Contact information of other people may also be collected from or submitted by you during the transaction process or for other communication purposes. You may, however, visit our site anonymously by enabling the ‘private browsing’ feature in your internet browser. Please note that when you visit our site anonymously you may not be able to access certain features on the site or use the DealTap services.

HOW WE COLLECT INFORMATION

The information we collect from you may be used in the following ways:

- To personalize your experience (your information helps us to better respond to your individual needs);
- To improve our website, products and services (we continually strive to improve our website, product and service offerings based on the information and feedback we receive from you);
- To improve customer service (your information helps us to more effectively respond to your customer service requests and support needs);
- To communicate, process or complete a transaction on DealTap with other parties involved. Your information will not be shared, sold, exchanged, transferred, or given to any other party without your consent, other than for the purpose of providing



the DealTap services, as required or permitted by law, or in accordance with this Policy this;

- To administer a contest, promotion, survey or other site feature;
- To process payment for the subscription and use of our products and services. We collect and use personal and financial information to process payment for your subscription to the DealTap services;
- In response to a valid court order, subpoena, government investigation, or as otherwise required by law. We also reserve the right to report to law enforcement agencies any activities that we, in good faith, believe to be unlawful. We may share certain personal information when we believe it is reasonably necessary to protect the rights, property and safety of others and DealTap. This may include, without limitation, the sharing of certain personal information with the Ontario Real Estate Association in the event of any material breach of our Terms of Service governing the access and use of the DealTap platform and services which can be viewed at <http://dealtap.ca/terms>
- To send periodic emails to the email address you provide for order processing, blog subscriptions, and information and updates pertaining to your account, company news, events, and new products or services that may be of interest to you.

Note: If at any time you would like to unsubscribe from receiving our emails, we include detailed unsubscribe instructions at the bottom of each email.

We also use the information you provide about third parties for communications required during the transaction process. If you provide personal information about your client(s)/ collaborator(s) to DealTap for the purpose of completing a transaction, you represent and warrant that you have obtained their consent to do so. Such information may be shared with other third parties for the purposes of completing a transaction.

Personal information may only be disclosed to third parties for the fulfillment of any purposes identified above, as required or authorized by law, or with your consent. Where personal information is disclosed to a third party for the fulfillment of any purposes identified herein, DealTap will make all reasonable efforts to ensure that the third party has appropriate security procedures in place for the protection of the personal information transferred to it.

Personal information is retained only as long as is necessary for the fulfillment of the purposes for which it was collected, or as required by law.

HOW WE PROTECT YOUR INFORMATION

We have implemented a variety of security measures to maintain the safety and security of your personal information when you enter, submit, or access your personal information on our website and via the DealTap services.

We offer the use of a secure server. All personal, financial and credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our payment gateway provider's database only to be accessed by authorized parties with special access rights to such systems, whom are also required to keep such information confidential. After the completion of a payment transaction, your personal and financial information will not be retained for more than 60 days.



We also ensure our users of the DealTap platform and services are protected with the highest standards of security through the implementation of various security protocols. DO WE USE COOKIES?

DealTap.com uses cookies. Cookies are small files that a site or its service provider transfers to your computer's hard drive through your Web browser (if you allow) that enables the sites or service provider's systems to recognize your browser and capture and remember certain information.

When you visit our website, we may assign your computer one or more cookies to facilitate access to our site and to personalize your online experience. Through the use of a cookie, we also may automatically collect information about your online activity on our website, such as the web pages you visit, the time and date of your visits, the links you click, and the searches you conduct on our site. While the information collected cannot be used to identify you, a cookie provides important aggregate data for our marketing department.

We may allow third-parties, including our authorized service providers and advertising companies, to employ third-party cookies to collect anonymous information about you. Our website does not provide any personal information to these third parties. This information may allow them to deliver targeted advertisements and gauge their effectiveness.

During your visits to other websites, we (or other third parties) may use certain anonymous, non-personal information collected on our site to show you advertisements likely to be of greater interest to you. This is called Online Behavioural Advertising (OBA) via the Google Network. For example, many companies have special offers and promotions that are targeted to new or prospective real estate buyers, including special mortgage rate offers, insurance, moving companies etc.

None of the OBA techniques we use will collect personal information such as your name, email address, mailing address or phone number.

How to Opt-Out of OBA and Disable Cookies

Certain of our service providers use the Google Network to show you advertisements based on your online behaviour. The use of cookies by our service providers is not covered by our Privacy Policy. We do not have access or control over these cookies. Our service providers use cookies to help DealTap advertise services that may be of interest to you. If you want to opt-out of receiving online behavioural advertising, please visit this [page](#) and click on the opt-out settings for interest-based Google ads across the Web. This does not mean that you will no longer receive advertising when visiting other sites, it just means that the advertising you see will not be customized for you based on your online behaviour.

Most browsers have cookies enabled by default, but you can usually modify your browser settings to disable cookies. If you choose to disable cookies, please note that you may not be able to sign-in or use some of the interactive features offered on our website.

We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or other's rights, property, or safety. However, non-personally identifiable visitor information may be provided to other parties for marketing, advertising, or other uses.

ACCURACY OF INFORMATION

DealTap will make all reasonable efforts to ensure that personal information is as accurate, complete, and current as required for the purposes for which it was collected. In some cases, DealTap relies on individuals to ensure that certain information about them, such as their address and contact information, is current, complete, and accurate.
