I also understand that the Center does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Insurance

I understand that Randy and Friends does not carry or maintain health, medical, or disability insurance except for Worker's Compensation for paid staff members.

Other

I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Georgia and that this Release shall be governed by and interpreted in accordance with the laws of the State of Georgia. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

Confidentiality Policy Statement for Volunteers, Interns, Students, Projects

1. Families being served in any way by Randy & Friends, Inc. have the right to control the nature of disclosures of information about their families and their child(ren).
2. Any communication to or observation by a Randy & Friends volunteer, staff member, student or visitor that is clearly not intended to be disclosed to a third party will be held confidential.
3. Information considered confidential includes:
 - a. using full names of individuals and family members served by Randy & Friends;
 - b. information transmitted in confidence by parents;
 - c. information transmitted in confidence about the person by family, neighbors, and other community service providers;
 - d. any disposition, referral, diagnosis, opinions, summaries, instructions, etc. issued for or about the individual and family, the course of evaluations, treatments or other services.
4. Verbal information can be exchanged between community service providers in order to make referrals or to provide continuity of care. Verbal information will be treated with the same concern for personal rights and confidentiality as written information.
5. Families served by Randy & Friends have the right to inspect and request amendments to formal documents generated to provide professional services (evaluators, developmental assessments, goals).
6. Written consent of the family being served will be obtained whenever written information is being transferred to another service provider.
7. Exceptions to the above policies are permitted only in bona fide medical emergencies where a medical consent form has been signed OR when release of information or treatment is regulated by law.
8. Randy & Friends has adopted policies to respond to situations including, but not limited to, lost individual, reporting illness-accident-injury, communicable disease, mandatory reporting of child abuse, emergency response to illness-accident-injury. Employees, substitutes, volunteers and university students/interns will be encouraged and supported and are required to cooperate in information gathering, reporting, internal communication, problem solving, resolution, and remedial action. Verbal and written communication to consumers, the media, the board of directors, and members of the community-at-large is managed by designated staff and board members to promote a professional and consistent and confidential process. Individual action, communication, reporting and professional and consistent and confidential process. Individual action, communication, reporting, and response outside the agency policies, procedures, and guidance of designated leaders is inappropriate.

Statement of Confidentiality

I will keep all information on Randy & Friends participants in the strictest confidence in accordance with Randy & Friends policies.
