You acknowledge that preserving the confidentiality of Confidential Information is an expectation and requirement of all Members and that you would not be given access to any Confidential Information or permitted to attend Events if you were not willing to agree to protect and preserve the confidentiality of all Confidential Information. You acknowledge that your breach of this Section 2 will cause irreparable harm, for which no adequate remedy at law exists, and that, in addition to all other rights and remedies LEAoP may have at law or otherwise LEAoP shall be entitled to immediate injunctive and/or other equitable relief to prevent a breach or continued breach of this Section.
