# IMPORTANT TRASH PICK UP INFORMATION



We are happy to announce that Waste Management was awarded a new contract with the township and will continue to be our trash collector.

As mentioned in prior newsletters, with this new contract the way your trash will be collected will change. Each residence will be provided (2) bins. One of the bins will be for trash and the other for recycling. These bins are similar to what you've seen in neighboring communities, like Bay City, Hampton and Merritt Townships.

### A Note from your Fire Chief, Randy Stefaniak

2022 has been quite the year. Inflation, Stock Market, COVID just won't go away and all those election phone calls, mail and TV commercials. You can get some piece of mind though. Make sure your home has working smoke and carbon monoxide detectors.

If you can't afford a smoke alarm, we will soon have some smoke alarms that we will install in homes in the township at no cost to you. <u>Smoke Detectors Save Lives</u>. You have heard that over and over. However, in order for smoke detectors to do their job they must be in working condition and be heard.

The good news is that according to a National Fire Protection Association report 96% of homes have smoke detectors installed. However, in 20% of these homes the smoke detectors were not working.

 In 70% of home fires where there was a fatality there were not working smoke alarms present.

- In half of the homes where smoke detectors were not working the batteries were missing. In the remainder the batteries were either dead or the smoke alarm was disabled or not in working condition.
- If every home had working smoke alarms home fire deaths would decrease 36% resulting in an estimated 1,120 lives saved per year

### What to do.

- Smoke and Carbon Monoxide alarms have a life of 10 years. If your unit is older than 10 years it is time to be replaced.
- Install smoke alarms that have a 10year sealed battery. This way you never have to change the battery.
- Install smoke alarms on each story and protecting every place that people sleep.
- Install smoke alarms that talk to each other so that a fire in one part of the house activates all smoke alarms. Alerting all occupants to get
- Familiarize children with the sound of your smoke alarm.
- Know the difference between the sound of the alarm and the chirping that tells you it needs a new battery.
- Test the smoke alarm each month.
- Develop a home fire escape plan, practice it with your children and designate a meeting place outside.
- And finally: once out, stay out! Once out of your home, don't go back inside for any reason. If people are trapped inside, fire fighters have the best chance of rescuing them.
