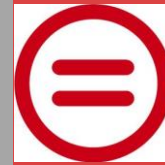

## Overview

The Pinellas County Urban League, in partnership with the Juvenile Welfare Board is requesting mini grant funding proposals for youth and family development activities in faith based communities.

## Eligibility Requirements

- Faith based institutions must have an existing youth component led by an adult who provides youth development activities.
- Organization must be tax exempt
- Provide services that align with youth development and community impact
- Serve youth below the age of 18
- Provide for adequate protection of youth and must comply with all applicable laws and implementing regulations, including but not limited to F.S. 435.
- Must not use funds to preferentially treat community partners, advisory group members, volunteers, personnel, or consultants
- *Funding is Cost Reimbursement.*

## In-Eligible Expenses

- Recreation programs that do not have a clear youth development component
- Direct medical services
- Services or programs requiring worship or religious instructional activities as a condition of participation
- Retirement of debt
- Charitable contributions
- Costs associated with legal settlement
- Personal expenses of Board members, staff, or volunteers
- Expenses associated with fundraising activities
- Costs not actually incurred or that are insufficiently documented

## Eligible Use of Fund

Funds are to be used to expand existing youth development activities to the surrounding community. *Funding is Cost Reimbursement.* Examples of activities include:

- Youth Community Project
- Youth Education
- Youth Leadership Development
- Other Innovative Youth and Family Projects

## Funding Amounts

- **\$500** Minimum > per organization
- **\$3,131.00** Maximum > per organization

**Total funds available: \$15,655.00**



## Proposal Scoring

Proposals will be scored base on the following criteria and points:

Basic Criteria	= 35 Points
Budget	= 30 Points
<u>Project Participant &amp; Community Impact</u>	<u>= 35 Points</u>
Total Points Available	=100 Points
