## REPORTING REQUIREMENTS FOR CRRSA ACT HIGHER ED EMERGENCY RELIEF FUND (HEERF II) GRANTS JUNE 30, 2021

Pontotoc Technology Center (PTC) has signed and returned, to the U.S. Department of Education (USDE), the Certification and Agreement and the assurance that PTC has used, or intends to use, the funds received under Section 18004(a)(1) of the CRRSAA Act (Coronavirus Response and Relief Supplemental Appropriations Act 2021) to provide HEERF II Grants to students.

The total amount of funds that PTC will receive or has received from the USDE, pursuant to PTC's Certification and Agreement for HEERF II Grants to Students: \$72,506.00.

The total amount of HEERF II Grants distributed to students under Section 18004(a)(1) of the CRRSAA Act (Coronavirus Response and Relief Supplemental Appropriations Act 2021) date of this report: \$33,318.31.

The estimated total number of students at PTC Tech who were eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive Emergency Financial Aid Grants to Students under Section 18004(a)(1) of the CRRSAA Act (Coronavirus Response and Relief Supplemental Appropriations Act 2021). 48

The total number of students who have received an Emergency Financial Aid Grant under Section 18004(a)(1) of the CARES Act as of 6/30/2021 is 48

The method(s) used by PTC to determine which students receive HEERF II Grants, and how much they would receive under Section 18004(a)(1) of the CARES Act: PTC disbursed HEERF II Grants to all post-secondary adults enrolled in an approved program at PTC. Students submitted a completed **CRRSAA Act (Coronavirus Response and Relief Supplemental Appropriations Act 2021)** attestation form to the Financial Aid Specialist. A straight proration method was used to determine the amount disbursed to each student. Each student received \$776.85 Pell Recipients and \$604.11 Non-Pell Recipients.

**Any instructions, directions, or guidance provided by the institution to students concerning the HEERF II Grants:** An individual email was sent to all 48 students informing them of their possible eligibility for a HEERF II Grant. The **CRRSAA Act (Coronavirus Response and Relief Supplemental Appropriations Act 2021)** telling them that attestation form (fillable PDF) was located on the Pontotoc Technology Center website. Students were asked to complete and sign the form and return it to the PTC Financial Aid Specialist as soon as possible. Upon receipt of the completed form and as requested by the student, the check was either sent by Certified Mail to the student, or students can come to PTC to pick it up from the Business Office.
