

Professional Man & Van Movers Group Terms and Conditions.

All U-Move Group

Man & Van Members will abide to U-MOVE GROUP LTD Terms & Conditions as laid out below.

1. Membership is on an annual basis and renewal may be declined at renewal date.
2. All Man & Van Members are to supply HQ with details of GIT Goods in Transit, Public and Employees Liability Insurance where applicable showing current dates.
3. All members must provide at least one commercial vehicle, panel or box van. The member's vehicle must be equipped with, panel van a minimum of 20 furniture covers/protectors, Box van minimum 40 furniture covers/protectors, a sack truck, general tool box and first aid kit.
4. Once accepted into membership a member will receive a membership certificate and 4 x vehicle door badges free of charge. Additional vehicle badges are available from HQ small £4.95 large £7.95 plus vat.
5. Man & Van Movers operate under their own terms and conditions of contract and insurance supplied by their respective insurers.
U-Move Group Ltd, The Directors, The Group as a whole or any other Member cannot be held responsible for any claim in part or full arising from any one or more dispute between a member and their customer/s.
6. The rates charged by the member are set by each individual member and are not governed by HQ. A guideline can be supplied by HQ if required although we feel rates may vary depending on members postcodes.
7. Man & Van Members will have access to discounted packing boxes at cost price based on a full trailer load 13 pallets, this can be mixed sizes, from our Affiliate Member delivered to them direct in white displaying the U - Move brand logo and in 3 sizes. Small 2 cuft medium 3 cuft and large 4 cuft.
Smaller quantities are available from our stockists at various UK locations. Delivery is available POA.
8. Man & Van Members will have access to discounted fuel cards through a member fuel card system along with other goods & services they may wish to supply.
9. Man & Van Movers Group encourage all members to promote and advertise OUR brand to create public awareness and build OUR Brand.

10. Membership of Man & Van Group is not restricted. A member could operate in several areas and there could be several members in any one area to supply services as required in busy periods.

11. U-Move Group supply Google landing pages in all member areas to attract private work. Members receive leads via HQ and contact client direct to advise their rate and if client dates are available etc..

This service is all part of the membership fee.

12. Man & Van Uniforms can be supplied by HQ if required.

15. All Man & Van members are to operate tail lifts and any other machinery.

16. No Man & Van members are to subcontract work to a third party under The U-Move Group Man & Van brand.

17. U - MOVE branded products such as packing materials etc may be used under the brand of other companies names, sold to DIY Movers, general public, third parties etc..

18. Any Member may collect & deliver goods in any other Members area on behalf of their client and other members

19. The Man & Van Movers annual subscription is fixed at £300 plus vat paid in advance for a period of 3 years from the date of initial membership. This may also be paid by 12 monthly instalments by standing order at £30 per month including vat. U – Move Group Ltd reserve the right to increase the cost of membership at any time for new members joining the group.

20. Members must telephone their customer prior to the agreed start time should the arrival time be later than previously agreed.

21. All members to register their Man & Van activities with their local council/ authority. Register forms available from U-Move Group HQ. Once registered an area licence will be issued to the member.

22. Membership available to anyone over the age of 17 years.
