Regular Council Meeting
Thursday, January 14, 2016 6:30pm
Council Chambers

The City of Loganville Mayor and Council met for their regularly scheduled Council Meeting on Thursday, January 14, 2016 at 6:30pm in the Council Chambers. Mayor Dan Curry and Council Members Chuck Bagley, Skip Baliles, Jay Boland, Mike Jones, Mark Kiddoo, Rey Martinez and Council-elect Linda Dodd were all present.

Mayor Dan Curry called the meeting to order at 6:32pm.

Rev. Russ Butcher gave the invocation and Boy Scout Javin Korpi led the pledge to the flag.

Council Member Chuck Bagley made a motion to table the agenda because 1/3 of the council has not had training. Motion died for lack of a second.

Council Member Mark Kiddoo made a motion amend the agenda move the 2016 CDBG Sidewalks under transportation and approve the agenda with the amendment. Council Member Rey Martinez seconded the motion. Motion carried 5-1 with Council Member Chuck Bagley voting in opposition.

Council Member Jay Boland noted for the record that he had nominated Mike Jones to the LDA to replace Mark Kiddoo and he has been sworn in.

Council Member Rey Martinez made a motion to approve the consent agenda as follows:

Council Member Mark Kiddoo seconded the motion. Motion carried 6-0.

Council Member Skip Baliles made a motion to approve the 2016 CBDG Side Walk Agreement for Fox Chase with the noted requirements under the agreement as presented. Council Member Mike Jones seconded the motion. Motion carried 6-0.

Council Member Mike Jones made a motion to approve the lease for 133 Camp Street with Greater Eastside Chamber of Commerce with the understanding that this in no way is an endorsement for the Chamber or make them the "official" chamber of the City of Loganville. Council Member Skip Baliles seconded the motion. Motion carried 6-0.


