

MINUTES

CITY OF LOGANVILLE
Regular Council Meeting
Thursday, February 9, 2017 6:30pm
Council Chambers

The Mayor and Council for the City of Loganville met for their regularly scheduled Council Meeting on Thursday, February 9, 2017 at 6:30pm in the Council Chambers. Mayor Dan Curry and Council Members Skip Baliles, Jay Boland, Linda Dodd, Danny Ford, Mark Kiddoo and Rey Martinez were all present.

Mayor Dan Curry called the meeting to order at 6:30pm.

Rev. Bob Hoffman from Loganville United Methodist Church gave the invocation and Council Member Mark Kiddoo led the pledge to the flag.

Council Member Mark Kiddoo made a motion to amend the agenda to remove Ivy Creek Project and Speed Hump Ordinance from the agenda and approve it as amended. Council Member Danny Ford seconded the motion. Motion carried 6-0.

Council Member Mark Kiddoo made a motion to approve the consent agenda as follows:

- a. Last Month's Minutes
- b. Last Month's Financial Report
- c. Capital Recovery Fee (Transfer of funds)
- d. Loan Proceeds - Elementary School Remodel

Council Member Jay Boland seconded the motion. Motion carried 6-0.

Planning and Zoning **Case #V17-001** was presented to the Council by Planning Director Tim Prater. He explained that PV-PB Athens, LLC has filed an application requesting a variance on approximately 2+/- acres to reduce rear and side buffers on property located at 185 Athens Highway, Map/Parcel #5159-254, Gwinnett County, GA. Mayor Curry asked if anyone want to speak in favor or opposition to the case. There was none. Council Member Skip Baliles made a motion to approve the case as presented. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Planning & Zoning **Case #V17-002** was presented to the Council by Planning Director Time Prater. He explained that Stone Mountain Atl Hwy, LLC has filed an application requesting a variance on approximately 2.871+/- to reduce the side yard setback on property located at 4200 Atlanta Highway, Map/Parcel #5160-192, Gwinnett County, GA. Mayor Curry asked if anyone want to speak in favor or opposition to the case. There was none. Council Member Skip Baliles made a motion to table this case and send it back to the Planning Commission. Council Member Rey Martinez seconded the motion. Motion carried 6-0.

Planning & Zoning **Case #R17-003** was presented by Planning Director Time Prater. He explained that Claude E. Hicks has filed an application requesting to rezone approximately

1.479+/- acres located at 4283 Pecan Street, Map/Parcel #LG05-0139, Walton County, GA. Mayor Curry asked if anyone want to speak in favor or opposition to the case. There was none. Council Member Skip Baliles made a motion to table this case and send it back to the Planning Commission. Council Member Danny Ford seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to approve the purchase of a 2017 Dodge Charger for the Police Department for \$33,934.50. Council Member Jay Boland seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to approve the purchase of four of the Nissan Leafs due to the expiration of their leases not to exceed \$25,000 for all four. Council Member Linda Dodd seconded the motion. Motion carried 6-0.

Council Member Rey Martinez made a motion to amend his previous motion not to exceed \$26,000. Council Member Linda Dodd seconded the motion. Motion carried 6-0.

Council Member Danny Ford made a motion to purchase the property located at 190 Covington Street for \$180,000. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

With no further business, Council Member Rey Martinez made a motion to adjourn. Council Member Jay Boland seconded the motion. Motion carried 6-0.
