

MINUTES

Regular Council Meeting
Thursday, January 11, 2018 6:30pm
Council Chambers

The City of Loganville Mayor and Council met for their regularly scheduled Council Meeting on Thursday, January 11, 2018 at 6:30pm in the Council Chambers. Mayor Dan Curry and Council Members Skip Baliles, Jay Boland, Linda Dodd, Danny Ford and Mark Kiddoo were present.

Mayor Dan Curry called the meeting to order at 6:30pm.

Congressman Jody Hice gave the invocation and the Color Guard from American Legion Post 233 led the pledge to the flag.

Old Business:

Council Member Mark Kiddoo made a motion to adopt the agenda under old business. Council Member Danny Ford seconded the motion. Motion carried 5-0.

Council Member Jay Boland made a motion to approve the consent agenda as follows:

- c. Resolution to adopt State Minimum Standard Codes for Construction
- d. Occupational Tax Ordinance Update (Housekeeping)

Council Member Skip Baliles made a motion to appoint Kathryn Self to a 4-year term (expires January 2022) and Amanda Sosebe to a 2-year term (expires January 2020) to the planning commission to replace Anne Huntsinger and Lisa Newberry. Council Member Linda Dodd seconded the motion. Motion carried 5-0.

City Manager Danny Roberts recognized outgoing Mayor Dan Curry and Council Member Mark Kiddoo for their service to the City and presented them with plaques on behalf of the employees and Council.

With no further old business to conduct, Council Member Linda Dodd made a motion to adjourn old business. Council Member Jay Boland seconded the motion. Motion carried 5-0.

At this time the Oath of Office was given to the following:

Council Member Danny Ford was sworn in by City Attorney Robyn Webb. Council Members Anne Huntsinger and Lisa Newberry were sworn in by Municipal Court Judge Lori Duff. Mayor Rey Martinez was sworn in by Probate Court Judge Bruce Wright.

Mayor Martinez called new business to order.

Council Member Linda Dodd made a motion to adopt the New Business portion of the agenda. Council Member Jay Boland seconded the motion. Motion carried 6-0.

Mayor Martinez opened the floor for nomination for Vice Mayor. Council Member Linda Dodd nominated Council Member Skip Baliles.


Council Member Danny Ford made a motion to close nominations. Council Member Anne Huntsinger seconded the motion. Motion carried 6-0.


Mayor Martinez presented and announced committee assignments for 2018.
