CITY OF LOGANVILLE Regular Council Meeting Minutes Thursday, August 9, 2018 6:30pm Council Chambers

The City of Loganville Mayor and Council met for their regularly scheduled Council Meeting on Thursday, August 9, 2018 at 6:30pm in the Council Chambers. Mayor Rey Martinez and Council Members Skip Baliles, Jay Boland, Linda Dodd, Danny Ford, Anne Huntsinger and Lisa Newberry were all present.

Mayor Rey Martinez called the meeting to order at 6:44pm.

Rev. David Harper from Holy Cross Anglican Church gave the invocation and Council Member Anne Huntsinger led the pledge to the flag.

Council Member Skip Baliles made a motion to adopt the agenda as presented. Council Member Anne Huntsinger seconded the motion. Motion carried 6-0.

Council Member Skip Baliles made a motion to approve the consent agenda as follows:

- a. Last Month's Minutes
- b. Last Month's Financial Report
- c. Approval of Annual Property, Auto, General Liability Insurance Invoices \$195,125.00 (Budgeted)
- d. 2019 Supplemental LMIG Project List - \$37,671.89 (30% City Match)
- e. Approval of City Owned Street Inventory
- f. Approval of LMIG 2018 Funds - \$38,448.20 (30% City Match)
- g. 2018 CDBG Project Engineering - Pecan Street - \$57,570.00
- h. State of Georgia Drinking Water Annual Lab Contract - \$10,640.00

Council Member Lisa Newberry seconded the motion. Motion carried 6-0.

Mayor Rey Martinez recognized and congratulated the Loganville High School 2018 State Championship Baseball Team.

Council Member Anne Huntsinger made a motion to approve the amendment to the Zoning Ordinance amending subsection 119-217(b)(1)(j) and 119-218(b)(5) to allow no more than eight (8) total automotive sales (used) facilities be permitted in the City of Loganville regardless of the zoning. Council Member Lisa Newberry seconded the motion. Motion carried 6-0.

Council Member Linda Dodd made a motion to adopt the revised Zoning Map as presented. Council Member Danny Ford seconded the motion. Motion carried 6-0. (Copy attached)

Council Member Anne Huntsinger made a motion to set the 2018 Millage Rate at 12.32 as recommended. Council Member Danny Ford seconded the motion. Motion carried 5-1 with Council Member Skip Baliles voting in opposition.

Council Member Anne Huntsinger made a motion to approve an amendment to the Group Activity Ordinance exclude the Town Green, Rock Gym, Ag Building Gaither Park and Destination Park from this ordinance, require reservations for any group activity in a park owned by the city and limiting those reservations to a maximum of four (4) times per year, per applicant. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

At this time Council Member Danny Ford made a motion to close open session and go into Executive Session for the purpose of discussing Real Estate Matters with Counsel. Council Member Linda Dodd seconded the motion. Motion carried 6-0.


Council Member Lisa Newberry made a motion to open Executive Session. Council Member Skip Baliles seconded the motion. Motion carried 6-0.

Council Member Danny Ford made a motion to close Executive Session. Council Member Linda Dodd seconded the motion. Motion carried 6-0.


Council Member Skip Baliles made a motion go back into open session. Council Member Anne Huntsinger seconded the motion. Motion carried 6-0.
