CITY OF LOGANVILLE Regular Council Meeting Minutes Thursday, September 9, 2021 6:30pm Council Chambers

The City of Loganville Mayor and Council met for their regular Council Meeting on Thursday, September 9, 2021 at 6:30pm. Mayor Rey Martinez and Council Members Jay Boland, Linda Dodd, Bill DuVall, Danny Ford and Anne Huntsinger were all present. Council Member Lisa Newberry was unable to attend.

Mayor Rey Martinez called the meeting to order at 6:30pm.

There was a moment of silence for the 13 soldiers lost in Afghanistan.

There was an invocation and the pledge to the flag was led.

Council Member Anne Huntsinger made a motion to approve the agenda as presented. Council Member Danny Ford seconded the motion. Motion carried 5-0.

Council Member Danny Ford made a motion to approve last month's minutes. Council Member Linda Dodd seconded the motion. Motion carried 5-0.

Council Member Jay Boland made a motion to approve last month's financial report. Council Member Danny Ford seconded the motion. Motion carried 5-0.

Walton County Chamber of Commerce President Teri Smiley gave an update on the Chamber and its partnership with the City of Loganville.

Steve Edwards with Waste Management gave an update on sanitation service and current challenges.

Dessa Morris was present and gave a presentation on the Walton Works program.

Lynne Horton and Teresa Thompson of the Matthew Talbot Chapter of the National Society Daughters of the American Revolution presented the City with a drop box to be placed at City Hall for people to turn in their worn, used and tattered flags to be properly retired.

Planning & Zoning Case #A21-007 was presented to the Mayor and Council. CAR Industries of Georgia, LLC requested to annex 2.379 acres to add to their existing property / business located at 4430 Tuck Road. The applicant was present and there was no one present to speak in opposition to this case. Council Member Danny Ford made a motion to approve the annexation as requested. Council Member Linda Dodd seconded the motion. Motion carried 5-0.

Planning & Zoning Case #R21-008 was presented to the Mayor and Council. CAR Industries of Georgia, LLC has requested to rezone 2.379 acres from B-3 (county zoning) to LI located at 4430 Tuck Road. Council Member Danny Ford made a motion to approve the rezone as requested. The applicant was present and there was no one present to speak in opposition to this case. Council Member Danny Ford made a motion to approve the rezone as requested. Council Member Bill DuVall seconded the motion. Motion carried 5-0.

Council Member Anne Huntsinger made a motion to set the 2021 Millage Rate at roll back rate of 11.561 mills. Council Member Linda Dodd seconded the motion. Motion carried 5-0.

Council Member Anne Huntsinger made a motion to approve the Mcci Laserfische Renewal for \$8,667.00. Council Member Danny Ford seconded the motion. Motion carried 5-0.

Council Member Anne Huntsinger made a motion to approve the Walton Press Contract for \$5,781.16. Council Member Jay Boland seconded the motion. Motion carried 5-0.

Council Member Jay Boland made a motion to approve the purchase of (2) 2022 Dodge Chargers for \$78,637.00 (includes a 10% contingency). This is a budgeted purchase however, should the purchase exceed the budgeted funds, and the remainder will be paid for with federal forfeiture funds. Council Member Anne Huntsinger seconded the motion. Motion carried 5-0.

Council Member Jay Boland made a motion to approve the Walton County Hazard Mitigation Plan Update as presented. Council Member Danny Ford seconded the motion. Motion carried 5-0.

Council Member Jay Boland stated that he would be appointing Greg Peoples to the LDA to be sworn in at a later date.

Council Member Bill DuVall made a motion to approve the flooring replacement for the Utilities Building for \$10,076.72. Council Member Linda Dodd seconded the motion. Motion carried 5-0.

Council Member Bill DuVall made a motion to approve the Cartegraph Software License Renewal for \$12,210.00. Council Member Jay Boland seconded the motion. Motion carried 5-0.

Council Member Bill DuVall made a motion to initiate procedures to terminate the Gwinnett County Speed Hump Program. Council Member Jay Boland seconded the motion. Motion carried 5-0.

Council Member Bill DuVall announced the GDOT Open House on September 23rd from 6pm to 8pm regarding the Traffic Study.


Council Member Linda Dodd announced the City would be holding a Dump Day on September 25th from 8am – noon.

Council Member Danny Ford made a motion to close open session and go into Executive Session. Council Member Jay Boland seconded the motion. Motion carried 5-0.


