

# FUR LIFE K-9 ACADEMY CLIENT AGREEMENT

The following are the terms of services for the Owner's Pet whose name is \_\_\_\_\_ as an overnight or day-use guest ("Guest") of Fur Life K-9 Academy.

I have received and reviewed my copy of the Rules, Regulations and Requirements. **Owner's Initials** \_\_\_\_\_

1. DISCLOSURE: By signing the Agreement and leaving Pet with Fur Life K-9 Academy, Owner certifies to the accurate disclosure of all information provided to Fur Life K-9 Academy either in writing or orally about the Pet. Owner specifically represents that he or she is the sole owner of the Pet, free and clear of all liens and encumbrances. Owner agrees to disclose to Fur Life K-9 Academy all known medical conditions and/or behavior problems, which may affect Pet's care. Owner specifically represents to Fur Life K-9 Academy that Pet is healthy and meets the Fur Life K-9 Academy's published vaccination standards. Owner certifies that each time their Pet is brought to Fur Life K-9 Academy, Owner is certifying that Pet is in good health and has not had any communicable illness of any kind for the last 30 days prior to visit. Client further agrees to inform Fur Life K-9 Academy of any changes in Pet's condition and/or behavior prior to subsequent visits. Fur Life K-9 Academy reserves the right to refuse service to any Pet for any reason, at any time, including, but not limited to: Pet lacking proof of vaccinations, Pet displaying signs of untreated or potentially contagious conditions and/or Pet exhibiting aggressive or unacceptable behavior. For the purposes of this Agreement, the terms "pet" refers to all pets under said ownership of Owner who utilize services at Fur Life K-9 Academy either now or in the future. **Owner's Initials** \_\_\_\_\_

2. RESERVATIONS AND DEPOSITS: A confirmed reservation is a reservation that has completed the following requirements: signed a copy of our Fur Life K-9 Academy Client Agreement, proof of vaccinations, a deposit and valid credit card on file. Reservations require one (1) night's advance deposit, except reservations during Peak/Holiday periods. Reservations must be cancelled at least three (3) days prior to arrival date, except reservations during Peak/Holiday periods. Failure to cancel the reservation at least three (3) days prior to the arrival date (including a "no-show") will result in forfeiture of the entire deposit. Peak/Holiday reservations

require two (2) night's advance deposit. Peak/Holiday reservations must be cancelled ten (10) days prior to the arrival date. Failure to cancel the Peak/Holiday reservation at least ten (10) days prior to the arrival date (including a "no-show") will result in forfeiture of the entire deposit. A "no-show" reservation is defined as more than 4 hours after the scheduled check-in time, at which time, the room will be released, the reservation cancelled, and the deposit forfeited. If Owner decides to shorten Pet's stay without proper notice, Owner will be charged for the entire original length of reservation. Fur Life K-9 Academy will cancel reservations due to non-performance by Owner with regard to the following items: incomplete vaccinations and/or invalid credit cards. Daycare and Grooming Reservations require 24-hours cancellation notice.

3. PAYMENTS: Owner agrees to pay the applicable service rates in effect on the date Pet is checked-in to Fur Life K-9 Academy and to pay for any additional services requested by Owner. Payment for all accommodations and services reserved will be paid for at the time of check-in. All additional or ancillary services will be paid upon check-out. **Owner's Initials** \_\_\_\_\_

4. EXTENDED STAY PAYMENTS: Stays exceeding two weeks require a payment of services for two (2) weeks at the time of check-in and then at the end of each week thereafter. Owner must maintain a valid credit card on file to be charged accordingly. **Owner's Initials** \_\_\_\_\_

5. NON-PAYMENT: Fur Life K-9 Academy shall have, and is hereby granted a lien on Pet for any and all unpaid charges resulting from service provided by Fur Life K-9 Academy. Owner hereby agrees that in the event charges are not paid when due in accordance with this Agreement, Fur Life K-9 Academy may exercise its lien right within ten (10) days after written notice has been given by Fur Life K-9 Academy to Owner by certified mail to the address shown on this Agreement. Fur Life K-9 Academy may dispose of Pet for any and all unpaid charges, at a private or public sale, at the sole discretion of Fur Life K-9 Academy, and the Owner specifically waives all statutory or legal rights to the contrary. If such sale shall not secure a price adequate to pay such costs of pet care or other charges, which are still due and outstanding from the Owner, plus the costs of sale, then Owner shall be liable to Fur Life K-9 Academy for the difference. All monies realized by Fur Life K-9 Academy at such sale, over and above the charges due plus internal expenses and costs of sale, shall be paid to the Owner. **Owner's Initials** \_\_\_\_\_

6. ABANDONMENT: Owner acknowledges that Owner has hereby been notified by Fur Life K-9 Academy that if Pet has not been retrieved, by Owner, within ten (10) days of Pet's scheduled pick-up date, then Fur Life K-9 Academy may deem Pet "abandoned" as described in Section 705.19, Florida Statutes. Fur Life K-9 Academy may then relinquish custody of Pet to the Palm Beach County Animal Control or the nearest Humane Society, or take other action as permitted by Florida Law. Despite any such abandonment, Owner will remain liable to Fur Life

K-9 Academy for all unpaid services and care charges, as well as, all fees and expenses associated with removal of Pet. Owner is further liable for any attorney's fees and costs incurred by Fur Life K-9 Academy in collection of such charges. **Owner's Initials** \_\_\_\_\_

7. ASSUMPTION OF RISK: Fur Life K-9 Academy agrees to exercise reasonable care of Pet during their stay and, if applicable, during transport. Owner acknowledges and is aware that the employees of Fur Life K-9 Academy are not veterinarians and do not have background in animal medicine and are not expected to diagnose or detect illnesses in the dogs utilizing services at Fur Life K-9 Academy. Owner further understands that dogs are pack animals, lead with their teeth, paws/claws and are unpredictable in nature. Owner acknowledges that no amount of vaccination requirements, supervision, sanitation or personalized care from Fur Life K-9 Academy can be 100% certain to prevent dog from being injured or contracting an airborne virus or communicable disease. Despite our extensive precautions, Owner understands these risks are inherent to the services and hereby releases Fur Life K-9 Academy, its employees, members or other agents, from any and all losses, damages, costs and expenses arising out of or in connection with any injury, communicable disease, airborne virus, or any other medical condition contracted by Pet at Fur Life K-9 Academy. This also applies to any claims for injuries or damages related to such medical care or transport. If dog is transported to or from Fur Life K-9 Academy by Fur Life K-9 Academy staff, Owner holds Fur Life K-9 Academy harmless in the event of injury or accident during transportation. Furthermore, Owner agrees to be held solely responsible for any and all acts and behaviors of Pet while in the care of Fur Life K-9 Academy, including payment of costs for injury to staff or other animals or damage to facilities caused by the dog. **Owner's Initials** \_\_\_\_\_

8. DAYCARE ASSUMPTION OF RISK: For safety reasons, Owner understands that Daycare Services are a privilege extended on to well-behaved, socialized dogs who have gone through an initial temperament evaluation and who have been deemed "acceptable" for such Service, in the sole discretion of Fur Life K-9 Academy. Fur Life K-9 Academy reserves the right to refuse service to any dog for any reason, at any time, including, but not limited to: dogs lacking proof of vaccinations, dogs displaying signs of untreated or potentially contagious conditions and/or dogs exhibiting aggressive or unacceptable behavior. All dogs six months of age or older must be spayed or neutered to participate in the Services. Owner understands that the Service's leash-free environment allows dogs the opportunity to play in close physical contact (including nose-to-nose) with each other. Owner further understands that dogs are pack animals, lead with their teeth, paws/claws and are unpredictable in nature. **Owner's Initials** \_\_\_\_\_

9. ACTS OF BEHAVIOR: Owner agrees to be solely responsible for any and all acts of behavior of Pet while in the care of Fur Life K-9 Academy, including payments of costs of injury to staff or other animals or damage to facilities caused by Pet. Owner also understands that squirt bottles

of water, citronella spray and, in extreme cases, muzzles may be used for the protection of other pets or staff. Owner further agrees to fully and completely indemnify and hold harmless Fur Life K-9 Academy, its agent and attorneys from and against any and all loss, claims, damage or expense, including attorney's fees, obligations, costs, expenses, fees, damages, judgments, penalties, or liabilities of whatever kind or nature imposed on, sustained or incurred by Fur Life K-9 Academy, its agents and attorneys from and against any and all loss, damages of any kind suffered by Fur Life K-9 Academy or its agents as a result of: any misrepresentation by Owner or their representatives, Pet's stay including, without limitation, any person claiming injury or damage caused by your Pet, Owner failure to inform Fur Life K-9 Academy of any pre-existing condition Pet may have (such as illness or aggression problems) or, any other injury, harm, or damage which is otherwise caused by Pet. **Owner's Initials** \_\_\_\_\_

10. PET HEALTH AND SAFETY: Fur Life K-9 Academy takes pride in the health and safety of our pet guests. All guests must be in good health and not have been exposed to any contagious or communicable illnesses within a 30-day period prior to check-in. Fur Life K-9 Academy will require veterinarian documentation proving a clean health record after treatment and/or medication has been administered and completed. Fur Life K-9 Academy accommodates pets that are healthy, fit and able to walk unassisted. Fur Life K-9 Academy cannot accept Pets with terminal illnesses and in the late stages of an illness. Fur Life K-9 Academy cannot accept Pets that require medical treatment beyond the dispensing of oral and topical medication and insulin injections (i.e. drains, bandage changes, suture removal, etc.) Fur Life K-9 Academy requires that all Pets be on a regular flea and tick program. If fleas are discovered upon check-in, a flea bath will be required at Owner's expense. Fur Life K-9 Academy may require the Pet guest receive a dose of Cap-star, at an additional charge of \$5, at check-in to eliminate possible fleas. Pet must possess a temperament that allows staff to care for the guests properly. Dogs are pack animals that lead with their teeth, paws/claws, and are unpredictable in nature. As a result, no amount of vaccination requirement, supervision, sanitation or personalized care from Fur Life K-9 Academy can be 100% certain to prevent pets from being injured or contracting an airborne virus or communicable disease. **Owner's Initials** \_\_\_\_\_

11. EMERGENCY/MEDICAL ATTENTION: In the event of an injury, emergency or when Fur Life K-9 Academy, in its sole discretion, deems medical care is important to Pet's health (including, but not limited to: vaccinations, fleas, ticks, diarrhea, rashes, cuts, etc.), Owner authorizes Fur Life K-9 Academy to obtain medical attention for the Pet in the event that the Owner, Pet's personal veterinarians, or the emergency contact provided cannot be reached. Fur Life K-9 academy will use reasonable efforts to attempt to contact the Owner, Pet's personal veterinarian, or the emergency contact provided to Fur Life K-9 Academy by Owner. In certain situations, an emergency may not provide the time for Fur Life K-9 Academy to contact Owner,

Pet's personal veterinarian or emergency contact person prior to administration of care. Owner therefore authorizes Fur Life K-9 Academy to obtain medical attention for Pet from any qualified veterinarian and to transport Pet to and from such veterinarian when Fur Life K-9 Academy, at its sole discretion, deems such medical care to be important to Pet's health. Owner grants Fur Life K-9 Academy and its employees or agent's full authority, at its sole discretion, to make decisions involving the medical treatment of Pet and agrees to pay for all related costs. This applies to any claims for injuries or damages related to such medical care or that arise due to the transport of Pet. Pet shall then remain at a veterinary hospital or similar location for supervision until such time as Owner, Pet's personal veterinarian, or Owner's emergency contact can retrieve Pet. In the event of a Pet's death, Fur Life K-9 Academy will attempt to immediately contact the Owner or the Owner's emergency contact using the contact information provided by the owner. In the event that complications, injury or death occurs due to the Owner refusing veterinarian recommended care, Fur Life K-9 Academy shall not be held responsible. Additionally, if medical treatment is refused for Pet, Fur Life K-9 Academy, at its sole discretion, may engage the services of a veterinarian and/or administer medicine in an effort to help make Pet as comfortable as possible until picked up by Owner, Pet's personal veterinarian or Owner's emergency contact, and Owner hereby agrees to fully pay for the expenses thereof. **Owner's Initials** \_\_\_\_\_

12. COMPLIANCE: Owner agrees to comply with the published policies of Fur Life K-9 Academy, which may be revised from time to time, with or without notice. In the event there is a discrepancy, this Agreement shall supersede the contents of the Rules, Regulations & Requirements. **Owner's Initials** \_\_\_\_\_

13. PRE-PAID PACKAGES: In the event that Owner decides to purchase a pre-paid package for services, Owner understands such sale price is offered at a special discounted in exchange for a non-refundable commitment to use all such fund at Fur Life K-9 Academy. Owner understands that after the sale, things may happen that are out of control of Fur Life K-9 Academy, including, but not limited to: the death of Pet, the relocation of Owner, behavioral changes in Pet, and the decision to stop utilizing Fur Life K-9 Academy for services. In any case, any unused portion of the sale (after deducting the used services at regular standard rates) shall be transferable for use on other services at Fur Life K-9 Academy, but in no instance, shall be refundable. Pre-Paid packages may not be sold or transferred to any Pet outside Owner's direct ownership. **Owner's Initials** \_\_\_\_\_

14. PROPERTY DAMAGE: Fur Life K-9 Academy reserves the right to charge an additional property damage fee for Pets that damage Fur Life K-9 Academy facilities. Property damage includes damages or destruction of beds, walls, crates, doors, furniture, televisions, etc. To avoid the potential of any unexpected fees, Fur Life K-9 Academy strongly recommends that Clients

who believe their Pet may cause property damage speak with a Fur Life K-9 Academy staff member in order to determine the best arrangement for their Pets. **Owner's Initials** \_\_\_\_\_

15. TRANSPORTATION: Owner agrees that Fur Life K-9 Academy pickup and drop-off service is an add-on service and offered on an as requested basis. Owner acknowledges and authorizes Fur Life K-9 Academy to transport the Pet to and from Fur Life K-9 Academy to the Owner's residence or other location as requested by the client. **Owner's Initials** \_\_\_\_\_

16. HURRICANE WAIVER: In the event of a hurricane or other natural disaster, Owner agrees that the Pet will be boarded at the Owner's own risk. Owner further agrees that Fur Life K-9 Academy makes no representations or warranties of any kind as to the safety of the Pet during a Hurricane and/or the period of time immediately following which the Pet may be under Fur Life K-9 Academy's care. Owner agrees to hold Fur Life K-9 academy harmless and shall otherwise indemnify Fur Life K-9 academy if Pet is injured, lost or harmed in any way during such time. Notwithstanding the foregoing, Fur Life K-9 Academy reserves the right, in Fur Life K-9 Academy's sole discretion to refuse the Pet during such time. **Owner's Initials** \_\_\_\_\_

17. ADVERTISING: Owner agrees that the names, likenesses of Owner, Owner's Family, Owner's agents or representatives and Owner's Pet(s) may be used on Fur Life K-9 Academy's website and within other advertising and promotional materials, including but not limited to, news programs as well as any other press, media, radio, television and/or internet coverage within the sole discretion of Fur Life K-9 Academy. **Owner's Initials** \_\_\_\_\_

18. ARBITRATION: This Agreement contains the entire agreement between two parties. All terms and conditions of this Agreement shall be binding on the heirs, administrators, personal representatives and assignees of Owner and Fur Life K-9 Academy. Any controversy or claim arising out of or relating to this Agreement, or breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Agreement, shall be settled in accordance with the rules of the American Arbitration Association, and judgement upon award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party. The arbitrator(s) shall apply Florida Law to the merits of any dispute or claim, without reference to conflicts of law rules. The parties hereby consent to the personal jurisdiction of the state and federal courts located in Florida and agree that such court shall have the sole and exclusive jurisdiction for any action or proceeding arising from or relating to this Agreement or relating to any arbitration in which the parties are participants. The parties understand that by signing this Agreement that they will submit any claims arising out of, relating to, or in connection with this agreement or the interpretation, validity, construction, performance, breach or termination thereof, to binding

arbitration, and that this arbitration clause constitutes a waiver of the party's right to jury trial and related to the resolution of all disputes relating to all aspects of the relationships between the two parties. **Owner's Initials** \_\_\_\_\_
