

## **Terms and Conditions for Veloce Esports Competition (the “Competition”)**

### **1. THE ORGANIZER AND PROMOTER**

- 1.1 Veloce Esports Limited, of Wessex House, Teign Road, Newton Abbot, Devon, TQ12 4AA (the “Promoter”) is organizing and managing the competition.

### **2. HOW TO ENTER**

- 2.1 No purchase is necessary to enter.
- 2.2 Entrants may enter by Instagram, by following Veloce Esports and their Partner(s) (Elgato, Playseat, Logitech) page, liking the post, and tagging a friend in the comments of the relevant competition post. Entrants may enter by Twitter, by following Veloce Esports and their Partner(s) (Elgato, Playseat, Logitech) page, liking the post, and retweeting the relevant competition tweet. Entrants may enter by Facebook, by following Veloce Esports and their Partner(s) (Elgato, Playseat, Logitech) page, liking the post, and tagging a friend in the comments of the relevant competition post. Only one entry per person will be accepted, and you may not enter on behalf of anyone else or as part of a joint entry. Entrants must comply with the eligibility criteria as well as the other rules and conditions set out in these terms and conditions.
- 2.3 The giveaway prize are the items stated in the relevant social media post. No cash alternative will be offered. Prizes are non-refundable and non-exchangeable. The prize cannot be sold on by the winner. The Promoter reserves the right to withdraw a prize at any time if it appears on eBay or any other reseller platform, or if the Promoter learns by other means that the winner is selling it on.

- 2.5 By submitting their entry, entrants will be deemed to have agreed to be bound by these rules. (Entries through agents or third parties will be invalid). 6.2 You agree to grant Promoter a non-exclusive, worldwide, irrevocable licence, for the full period of any intellectual property rights, in the competition entry, to use, display, publish, transmit, copy, edit, alter, store, re-format and sub-licence the competition entry in connection with any publicity in relation to the Competition.

#### **7. WINNING ENTRY DETAILS**

7.1 The name of the winner will be sent to anyone who writes within three months after the closing date, enclosing a stamped addressed envelope, to the Promoter at the address set out at the top of these terms and conditions, requesting details of the winning entry.

**8. DATA PROTECTION AND PUBLICITY**

8.1 By entering the competition, you agree that any personal information provided by you with the competition entry may be held and used by the Promoter to:

- (b) carry out our obligations arising from these terms or any contracts entered into between you and us; and
- (c) provide you with information, products or services that you request from us or which we feel may interest you, where you have consented to be contacted for such purposes.

**9. LIMITATION OF LIABILITY**

9.1 To the extent permitted by law, the Promoter excludes all liability for any loss, damage, personal injury or death, loss of reputation or loss of opportunity, and any liability to compensate the winner or any other entrant as a result of the prize, or taking up the prize or the operation of this Competition, save to the extent such loss results from the gross negligence of the Promoter

**10. GENERAL**

10.1 If there is any reason to believe that there has been a breach of these terms and conditions, the Promoter reserves the right in its absolute discretion to exclude one or more entries from participating in the competition.

10.2 The Promoter reserves the right to hold void, suspend, cancel, or amend this prize competition where it becomes necessary to do so.

10.3 These terms and conditions shall be governed by English law, and the parties submit to the nonexclusive jurisdiction of the courts of England.
