

Sanctions chart

All consequences and sanctions are issued due to failure to meet our school philosophy and expected behaviour standard. The philosophy is detailed on the next two pages.

	Examples of Behaviour	Sanctions
C1	Failure to follow the school philosophy and expected behaviour standard.	Staff to select from: 1. Verbal warning 2. Discussion with pupil
C2	Repetition of C1 behaviour – Failure to follow the school philosophy and expected behaviour standard as above.	3. Phone call home 4. Letter home 5. Break detention 6. Lunchtime detention 7. After-school detention
C3	Repetition of C2 behaviour in same lesson – Failure to follow the school philosophy and expected behaviour standard. Repeated C3 can result in pupil parking within departments or “senior response” to deal with a problem if serious disruption is occurring (C3 sanction still stands) If a senior response is necessary the pupil will be isolated for the day.	Staff to select from: Lunchtime detention or after-school detention and discussion with pupil.
C4	Persistent / repeated C3 behaviour – Failure to follow the school philosophy and expected behaviour standard. Deliberate defiance Inappropriate use of phone / ICT (cyber bullying, indecent etc) Fighting / assault / dangerous behaviour Bullying 2 C3s in one day will send automatic alert for Behaviour Manager but will not automatically trigger behaviour team intervention.	9-5 sanction or Isolated 9-5 (PD staff discretion)
C5	Persistent / repeated C4 behaviour – Failure to follow the school philosophy and expected behaviour standard. Poor Behaviour in C4 sanction Discriminatory abuse or bullying (including racist, homophobic and aimed at / in reference to people with disabilities) Theft, graffiti or vandalism Possession of / bringing in inappropriate items.	Isolation(1 – 5 days) or direction. (PD staff and SLT discretion).

C6	<p>Poor behaviour during / refusal of a C5 sanction</p> <p>Persistent C5 behaviour – Failure to follow the school philosophy and expected behaviour standard.</p> <p>Swearing at a member of staff/ inappropriate physical contact with staff</p> <p>Extreme graffiti / vandalism</p> <p>Violent behaviour/serious fight /assault</p> <p>Persistent bullying</p> <p>Malicious allegations towards staff</p> <p>Possession of illegal or controlled drugs / alcohol</p>	<p>Fixed term exclusion</p> <p>Fixed term exclusion – but possible escalation to</p> <p>Permanent exclusion</p>
C7	<p>Persistent C6 behaviour</p> <p>Possession of offensive weapon</p> <p>Serious theft</p> <p>Intent to supply illegal drugs / supply of illegal drugs</p> <p>Violence towards member of staff</p>	<p>Permanent Exclusion</p>
