- Our portfolio is long-only and concentrated



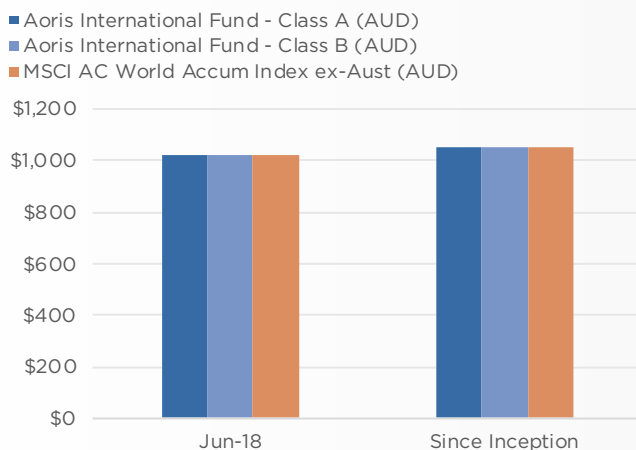

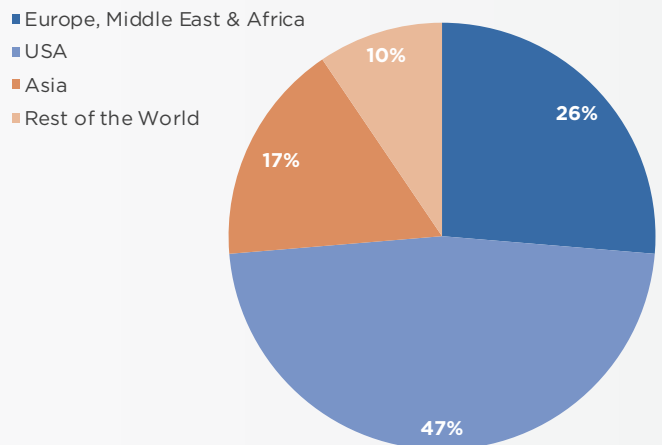
