- We achieve diversification by owning businesses with significant breadth in the end markets they serve

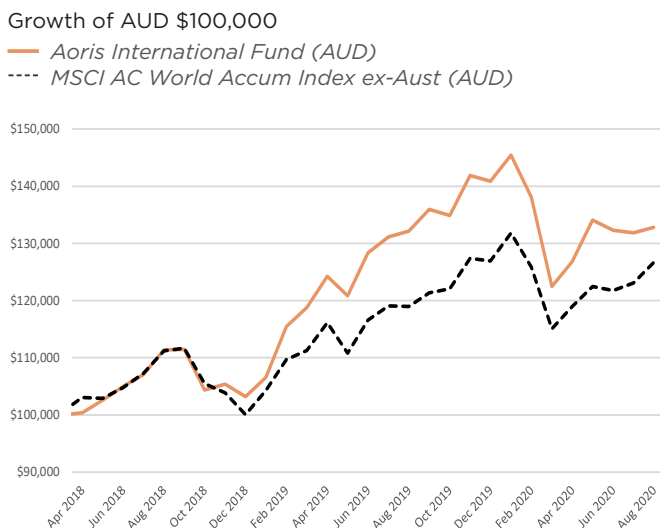

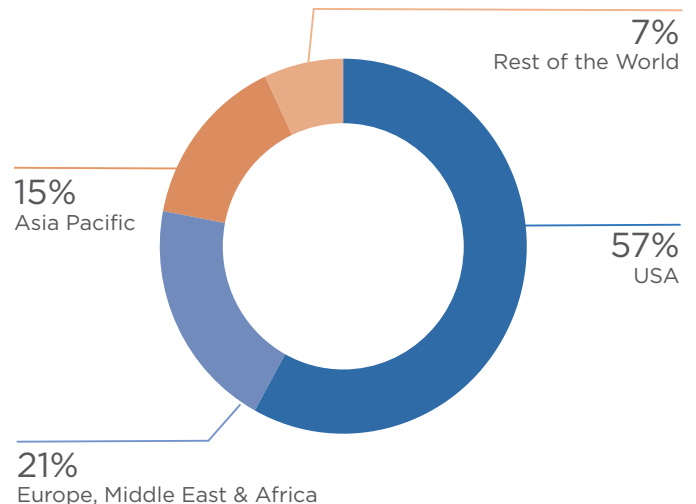
