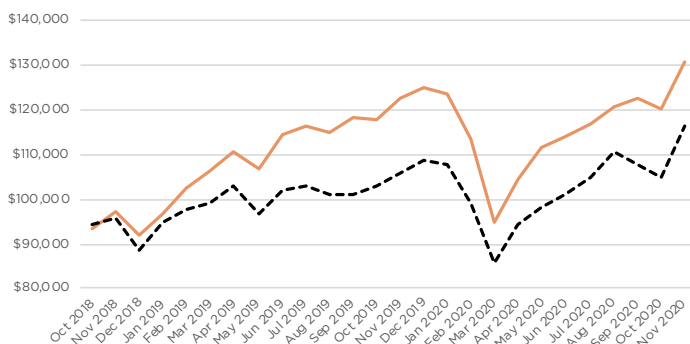

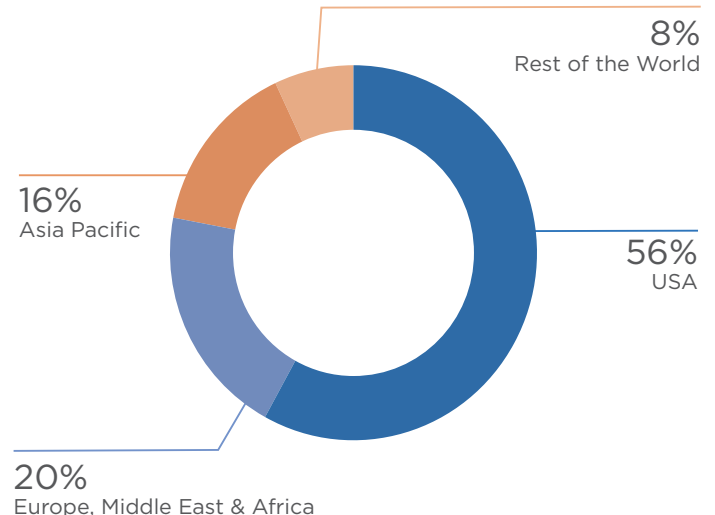
### Performance since inception - Class C
