





## Getting out the Vote (GOTV)

**Door-to-Door Canvassing:** The League is dedicated to empowering people to vote. As one of the only nonpartisan civic organizations in the state, we are uniquely positioned to get people to the polls, regardless of their party affiliation! This year, we piloted our first door-to-door canvassing program in low turnout areas to reach people who are losing trust in our democracy and get the word out about Vote411.org.


**Phone Banking:** After successfully piloting phone banking during the June 2019 Primary Election, we expanded our efforts for the November General Election. Phone banking provides an easy and efficient way for League volunteers to directly reach out to voters to ensure they have all the information they need to cast an informed ballot.

## Getting out the Count (GOTC)

The League is committed to achieving a complete and accurate count for Census 2020. The Census count affects nearly \$23 billion federal funding annually, supporting hospitals, schools, childcare, infrastructure, and so much more. The Census also plays a role in determining New Jersey's number of seats in the House of Representatives, our number of votes in the Electoral College, and redistricting.

## Vote411.org



Vote411.org, our online voters guide is a one-stop online resource that provides nonpartisan voting information you cannot find anywhere else. It is one of our most valued resources. A voter visits the website, enters his or her address, and can see his or her ballot, including candidates' responses to policy questions. Because of your support we have achieved our goal of covering every state and county race in New Jersey! **In 2020 we are committed to doubling our hyper-local coverage of town and school board elections.**

## Returning Citizens

Through a statewide partnership with the New Jersey Reentry Corporation, the League of Women Voters of New Jersey's local Leagues work in several different counties to help educate and register citizens post-incarceration. Led by League of Women Voters of Southern Monmouth member Annette Scott, our volunteers visit with returning citizens to hold classes about civic engagement, teach them their voting rights, and register them to vote. The League of Women Voters is committed to increasing voter registration and turnout, particularly among marginalized communities that face additional obstacles to the ballot. **In 2020, with your support, we will expand our efforts to reach returning citizens now that people who are on parole or probation are eligible to vote as well.**

## Civic Engagement & the Centennial



Along with dozens of partner organizations, the League of Women Voters of New Jersey is working with NJ Women Vote 100: The 19th Amendment at 100 to mark the centennial of women's suffrage. At the same time, we are acknowledging its inequities and the challenges New Jersey women of all backgrounds have faced and continue to confront from 1920 to the present day. Our organizations are working on programs across the state to educate voters about the importance of their voices and votes. **2020 plans include voter registration drives, a Suffragist March, and speaking engagements.**

# IMPACT: DEFENDING DEMOCRACY

The League of Women Voters of New Jersey is a prominent presence in the halls of the State House. This legislative session, your support helped accomplish historic victories including defeating a flawed redistricting proposal, restoring the right to vote to over 80,000 New Jerseyans on parole and probation, ending prison-based gerrymandering, and the passage of online voter registration.



## People Powered Fair Maps

People Powered Fair Maps™ is a national redistricting program of the League of Women Voters focused on creating fair political maps. The program includes actions in all 50 states + D.C. The goals of this large, powerful, coordinated League effort are to:

- Create fair and transparent, people-powered redistricting processes to eliminate partisan and racial gerrymandering in states nationwide.
- Ensure our political maps are created by the people – not those in power.
- Provide people with direct avenues for influencing the drawing of districts in their communities, ensuring voters choose their representatives instead of representatives choosing their voters.

We do not have to rely on the Supreme Court to solve partisan gerrymandering. There are other paths to creating Fair Maps nationwide – and the League of Women Voters is the best organization positioned to accomplish this.

As we approach our 100th anniversary and the centennial of women’s suffrage, we know that 100 years ago, women didn’t have a voice in government, and frankly some women were left out altogether. **Today, we are working to ensure that, as voters, we choose our representatives, so that everyone is counted, heard, and represented in government.**

The League has been instrumental in most major redistricting reform efforts – from fighting for some of the first major reforms in states like Arizona, California, Florida, and Iowa, by creating independent commissions or binding redistricting criteria – to the recent passage of ballot initiatives in Colorado, Michigan, Missouri, and Utah, and implementing and defending these reforms once passed.

This work around redistricting is grounded in social justice and racial equity. We are committed to ensuring underrepresented populations have a real chance to elect their candidate of choice.

# FAIR DISTRICTS NEW JERSEY

Our Fair Districts New Jersey campaign is advocating for community-centric redistricting reforms to improve our line-drawing process and put more power into the hands of the people.

## RALLYING FOR FAIR DISTRICTS

Late in 2018, over the Thanksgiving and winter holidays, legislators introduced flawed redistricting proposals that would have laid the foundation for partisan gerrymandering and voter suppression. Because of your support, the League of Women Voters of New Jersey was there to defeat these proposals. It was a great moment for democracy.

The League had once again shown that the power of the people is greater than the people in power. Over 50 organizations mobilized alongside us and joined us for a press conference to sound the alarm, and nearly 100 advocates came together in Trenton to testify in opposition. Thousands of our supporters called their legislators, wrote letters to the editor, tweeted, emailed, and spoke out against these harmful redistricting proposals. We were there to shine a light, to mobilize the opposition, and to ensure voters were educated and their voices were heard. Our legislators know that the nonpartisan League is vigilant and powerful, and will quickly mobilize against any anti-democratic legislation, regardless of the party proposing it. None of this would be possible without your support. Thank you!

## VICTORY FOR VOTERS

At the end of 2018, the League of Women Voters of New Jersey, through our Fair Districts New Jersey campaign, mobilized a large and powerful coalition of organizations and grassroots advocates to defeat a flawed redistricting proposal from advancing.

## REDISTRICTING REFORM: BEST PRACTICES FOR A FAIRER NEW JERSEY

The League of Women Voters of New Jersey organized a series of educational forums across the state in early 2019 – “Redistricting Reform Best Practices for a Fairer New Jersey.” Since informed public input – not special interests – should influence policy making, it was important to understand which redistricting principles and criteria resonated most with New Jersey voters and how those values could be incorporated into future redistricting reform proposals. At the end of each presentation, participants submitted a survey response to share feedback on various redistricting principles and guidelines. A taped recording of the presentation available online expanded the opportunity for public participation and allowed viewers to submit a response electronically. In all, nearly 400 responses were collected over a 7-week period. From these responses, the League compiled a report, [“Redistricting Reform: Best Practices for a Fairer New Jersey”](#) that we circulated widely with legislators, stakeholders, activists, and the press in order to ensure that voter's voices were a large part of any redistricting conversations.



## ENDING GERRYMANDERING WITH PEOPLE-POWERED REFORMS: CONVERSATIONS WITH THE CALIFORNIA REDISTRICTING COMMISSION

Fair Districts New Jersey hosted members of the California Independent Redistricting Commission for a series of events highlighting how we can improve our democracy through community-centric redistricting reforms. The Commissioners shared their experiences as ordinary voters selected among over 30,000 applicants to draw California’s new district maps. In just over 2 days, we held 3 public town halls, a Facebook Live conversation, a business community meeting, lobbied at the State House, talked to the media, and reached hundreds of people with information about redistricting reform.

## VOTING RIGHTS CHAMPIONS

Fighting for a transparent and accessible democracy is at the core of everything we do. We challenge all efforts and tactics that threaten our democracy and limit the ability of voters to exercise their right to vote. We are at the forefront of the most important federal and state voting rights battles around the country and our efforts have resulted in the protection of voting rights and ballot access for millions of Americans.

## AN END TO PRISON-BASED GERRYMANDERING

After over a decade of League advocacy, New Jersey passed legislation to end prison-based gerrymandering. Ending prison-based gerrymandering means that incarcerated individuals will no longer be used to inflate the political power of areas that house correctional facilities. Counting people in correctional facilities for redistricting purposes has undermined the Constitutional principle of “one person, one vote.” Also, due to the extreme racial disparities in New Jersey’s incarceration rates, prison-based gerrymandering has severely denied Black and Latinx communities a full voice in our democratic processes. We now become the seventh state to correct this defect in our democracy. Thank you to everyone who took action to pass this bill – your advocacy and donations made all the difference!

## ONLINE VOTER REGISTRATION

New Jersey was one of only a handful of states that did not offer the opportunity to register to vote online. After a decade of advocacy and with you by our side, we were able to get online voter registration over the finish line. Governor Murphy signed online voter registration legislation in January 2020!

## RESTORING THE RIGHT TO VOTE FOR PEOPLE ON PAROLE AND PROBATION

New Jersey was falling behind – no other state in the Northeast denied voting rights to as many people living in the community as New Jersey did. For over a decade, working with our partners we lobbied to correct this grave injustice. We met with the public and legislators to talk about the transformative power of voting. Because of your support and advocacy, Governor Murphy signed legislation restoring voting rights to people on parole and probation. Because of you, over 80,000 New Jerseyans can now fully participate in their democracy.
