Table of Cemetery Fees relating to Olney Cemetery to come into force on 1st April 2018

The fees, payments and sums set out below apply where the person to be interred or in respect of whom right is granted is, or immediately before his death was, an inhabitant or parishioner of the Parish of Olney or, in the case of a still-born child, where the parents (or one of them) are, or at the time of the interment were such inhabitants or parishioners.

In all other cases the fees, payments and sums will be doubled, except that those set out in Parts 1 and 4 will not be doubled where the exclusive right of burial in the grave in question, or the right of constructing the grave or vault, was acquired at the single fee as set out in parts 2 and 3.

INTERMENTS

The fees indicated for the various heads of items 1, 2, and 3 apply only where interment is made between the hours of 9:30 a.m and 3:30 p.m Monday to Thursday and 9:30 a.m. and 12:00 noon on Friday or on the certificate of a coroner or a registered medical practitioner that immediate interment is necessary. In any other case an additional **£52.50** is payable.

EXCLUSIVE RIGHT OF BURIAL IN EARTHEN GRAVES

4.	For the exclusive right of burial in an earthen grave	£248.00
5.	For the exclusive right of burial of cremated remains in an earthen grave 2 feet x 1 foot	£209.00

The fees indicated for the various heads of this Part include the cost of the Deed of Grant.

MONUMENTS, GRAVESTONES, TABLETS AND MONUMENTAL INSCRIPTIONS

6.	For the right to erect or place on a grave or a vault in respect of which the exclusive right of burial has been granted:	
i.	a tablet not exceeding 12" x 18"	£131.00
ii.	a flatstone	£165.00
iii.	a headstone	£165.00
iv.	a vase not exceeding 18 inches (0.4 metres)	£84.50

The fees indicated for the various heads of this Part include the first inscription. For each additional inscription after the first fee a fee of **£38.00** is payable.

Fees for searches of register books, and for copies and extracts to be taken there from: -	
Every search covering a period of more than one year:-	
for the first year	£13.20
