

Charlie House – Run For Charlie House Terms & Conditions (Banchory Beast Race)

Minimum Sponsorship Agreement

1. I understand that by signing up to this event I agree to raise at least the minimum sponsorship target of £150.00. However, I understand that the object is to raise as much sponsorship as possible.
2. I understand, that should I cancel my Race Entry with less than 14 days remaining before the date of the event, I will be liable to pay for the Entry Fee associated with the event Race I have applied for when completing this registration form, you will not be held responsible for the entire total associated with the minimum sponsorship agreement.
3. By agreeing to this Minimum Sponsorship Agreement, I agree to actively fundraise in support of Charlie House, in return for a charity place in the Banchory Beast Race.
4. I understand, that in circumstances where we (Charlie House) deem that I have not actively attempted to raise the minimum sponsorship target associated with the event entered (in our reasonable opinion), I will be liable to either pay the Entry Fee associated with the Beast Race*, or have my participation into the Beast race withdrawn.

*Standard Beast Race Entry fee is £75.00

Introduction

- What these terms cover. These are the terms and conditions on which we supply services to you in relation to the arranging and delivery of activities and events associated with Run for Charlie House.

Bookings and Cancellations

1. I understand that events organised as part of “Run for Charlie House” are third-party events, and Charlie House take no responsibility for the cancellation or postponement of a race for any reason outside our control. In such circumstances, you will be entitled to either: (i) cancel your place; or (ii) participate in an alternative comparable race (available options will be offered to you by a relevant member of Charlie House staff). We will not be obliged to compensate you for any other expenses that you may have occurred in connection with the cancelled/postponed event.

Your rights to cancel or reschedule your booking

2. In circumstances where we deem a change in your circumstances to be significant (in our reasonable opinion), we may give you the option to either: (i) cancel your charity race entry place; or (ii) attend an alternative comparable race (available options will be offered to you by a relevant member of Charlie House staff). We will not be obliged to compensate you for any other expenses that you may have occurred in connection with the race entered.
3. In addition to your right to cancel your booking in the circumstances described in clause 2. above, if you are a consumer and you have changed your mind about your race entry or sustained an injury, you may cancel your race entry up to 14 days before the date of the event you have entered. You will not be held responsible for the Minimum Sponsorship Agreement if you cancel your entry before this 14-day period. For the avoidance of doubt, you may not cancel your booking under this clause 3. less than 14 days before the date of the event you have entered.

4. Should you cancel your Race Entry with less than 14 days remaining before the date of the event you have entered, you will be liable to pay for the Entry Fee associated with the event you have entered – you will not be held responsible for the entire total associated with the minimum sponsorship agreement.

Health and Safety

5. Safety and Participation. You acknowledge that the chosen race entered may be hazardous with a danger of personal injury. Whilst Charlie House and the Third Party organizer will use all reasonable endeavors to ensure the safety of attendees at races, you accept that you will be responsible for your own actions and those of your group while attending any of the races entered as part of Run for Charlie House.
6. Age Restrictions. Certain races entered are subject to age restrictions – please see the booking platform for each race for further details. Any attendee under 18 years of age must have explicit permission of his/her parent or guardian before attending any third party race arranged and/or delivered as part of Run for Charlie House.
7. I understand that I should seek medical advice from my general practitioner if I am in any doubt about my physical ability to take part in this event. I acknowledge that I am undertaking this activity entirely at my own risk and that Charlie House shall not be liable in any way for any injury or loss that might occur as a result of my participation. I agree to pay all proceeds from the event to Charlie House.

Security

8. Charlie House accepts no responsibility for the property of persons attending an event. Vehicles and their contents are parked in car parks at their owners' risk. Charlie House accepts no responsibility for any loss or damage incurred thereto. Any property brought on to the race premises, including baggage or the contents of said baggage, or left in the car parks when attending a race as part of Run for Charlie House, is done so entirely at the owner's risk.
