

We currently accept 3 types of articles:

**-- Current Events --**

These articles must be about a current event pertaining to Social Security, Medicare/Medicaid, Student Loans, or the Federal Budget. The best submissions answer these questions: What's the current event? What questions does this event raise for the future of the program? What's the debate around it look like? What should the reader keep an eye on, or in other words, why should the reader care?

*Examples: The Social Security Administration makes an announcement, the president issues an executive order on student loan debt, or there's a House debate around a Medicare bill.*

**-- Event Recap --**

So you went to an event on your campus, whether that's virtual or in-person! Share what was discussed at the event, what it meant to you, and what a student from another campus could learn from your experience.




*Examples: [Pete Souza](#) speaks at your school, there's a debate between two policy experts about an issue, or an expert delivers a presentation about rising healthcare costs.*

**-- "We Read It So You Didn't Have To" --**

Think tanks publish policy white papers every day... so often that the average reader can't possibly keep up with them! In your article you'll give a TL;DR summary of the white paper, pick out key points the reader should care about, and share your biggest takeaway.

*Examples: AEI releases their analysis of the federal budget, Brookings writes a paper on Medicaid and health outcomes, or Urban Institute releases findings on healthcare market pricing.*

Keep in mind, we *don't* accept:

-  Opinion pieces
-  Original policy write-ups
-  Articles on unapproved topics
