Governance Review

We have recently completed a skills audit which informed the recruitment of our new Trustees. Alongside this we have established three new sub-committees to strengthen our governance processes and provide additional support to the organisation at this difficult time. We are also taking time to stop and consider whether our current constitution is fit for the future and will support the development of our service offering.

Our current Powers under the Charity's Articles of Association were set out in 1985, more than 35 years ago. Although these Articles were amended in 2006 the original template they are based on is now outdated and it has become apparent that these should be revised to be in line with the current model template for Charities that are also Limited Companies. This will enable us to make the governance procedures more suitable for the future and widen the scope of what we do whilst remaining true to our original Objects (purpose).

Working with Law Firm Lewis Silkin who are kindly supporting us on a pro-bono basis, the Nominations, Remuneration and Governance Committee are working to update the Articles of Association and will make a series of proposals. We intend to hold a series of consultancy events with members to refine this further.

In conclusion

So, we meet at a testing time and we should not underestimate the challenge ahead. Tackling the pandemic and its consequences continues to demand much from us all and it is not yet over. However, I believe we have the people, skills, ideas and imagination to tackle this challenge and to move forward. We have a talented and innovative staff team, a strong and diverse board, better management practices and systems and a real opportunity to try some new ideas and products for the organisation. This means we are now in the strong position to face this challenge and I look forward to working with you all during 2021 to make this happen.
