

## PRIVACY POLICY

Weller Management Company, LLC (“Weller” or “we”) respects your privacy and is committed to protecting your personally identifiable information (“PII”) that may be collected through your use of our website [wellermanagement.com](http://wellermanagement.com) (“Site”). This privacy policy (“Policy”) describes how we collect, use, and share your PII and how you can control that use. Please read this Policy carefully. By using our Site, you agree to our collection, use, and sharing of your PII as described in this Policy.

### INFORMATION WE COLLECT

#### ***Information you provide to us:***

We do not require you to provide PII to navigate our Site. However, we collect information from you when you:

- Interact with our Site. When you fill out web forms, or interact with us in any way, you provide us with PII such as your name and email address.

#### ***Information collected automatically:***

We may automatically collect information as you use the Site. This includes browser type and Internet Protocol (“IP”) address.

#### ***Cookies and tracking technologies:***

- Cookies: “Cookies” are small pieces of information that are stored by your web browser software on your computer’s hard drive or temporarily on your computer’s memory. We use session cookies to make it easier for you to navigate our Site. Session cookies expire when you close your browser. We also use persistent cookies on our Site. These cookies remain on your hard drive for an extended period of time. We set a persistent cookie to store information about your preferences and customize your experience. Persistent cookies also enable us to track and target the interests of our users to enhance the experience on our Site. If you reject cookies, you may still use our Site, but your ability to use some areas of our Site may be limited.
- Google Analytics: We use a tool called “Google Analytics” to collect some information we listed above about your use of the Services. We use the information we get from Google Analytics to improve the Site. In order to collect this information, Google Analytics may set cookies on your browser or mobile device, or read cookies that are already there. Google Analytics may also receive information about you from apps you have downloaded, that partner with Google. We do not combine the information collected through the use of Google Analytics with PII. Google’s ability to use and share information collected by Google Analytics about your visits to the Services to another application which partners with Google is restricted by the Google Analytics Terms of Use and the Google Privacy Policy.
