In accordance with the Rules and Regulations of The Woodholme Country Club, no consideration for membership shall be reviewed unless the prospective member shall have complied with the following:

- 1) For applicants age 29 and under, such prospective members must contribute at least \$250.00 to organized charities for the year of their consideration of which a minimum of \$200.00 must be contributed to The Associated Jewish Community Federation of Baltimore.
- 2) For applicants age 30 to 39 inclusive, such prospective members must contribute at least \$800.00 to organized charities for the year of their consideration of which a minimum of \$500.00 must be contributed to The Associated Jewish Community Federation of Baltimore.
- 3) For applicants age 40 and over, such prospective members must contribute to organized charities at least \$1800 minimum – continuing, to The Associated Jewish Community Federation of Baltimore or one of its constituent agencies. From time to time the Board of Governors may reduce for a particular year the minimum amount required to be given or pledged to The Associated Jewish Community Federation of Baltimore. The Board of Governors shall set the minimum amount so required at the December meeting each year.
- 4) Any dues payable to Temples or Synagogues are not considered as charitable contributions.
- 5) The prospective members shall bind themselves on said membership consideration that they will continue in each year their charitable contributions based on their age from time to time in accordance with these membership minimum requirements during their membership in The Woodholme Country Club, upon penalty of expulsion.
- 6) The prospective member binds their child and spouse who subsequently become members in their own names to the above charitable requirements.
