### Terms and Conditions

**BY BOOKING YOUR PLACE ON THE RETREAT AND ELECTRONICALLY TICKING THAT YOU HAVE READ, UNDERSTOOD & AGREED TO THE TERMS & CONDITIONS THESE ARE THE TERMS YOU ARE BOUND BY.**

### Payment Terms

You agree to the payment due dates and amounts as follows:

All payments in NZ Dollars	Non-refundable deposit	Final payment
Retreat programme with DOUBLE BED and sole occupancy	\$697.50 (50% due at booking)	\$697.50 (due 3 weeks before the retreat begins)
Retreat programme with SINGLE BED and sole occupancy	\$625.00 (50% due at booking)	\$625.00 (due 3 weeks before the retreat begins)
Retreat programme with twin share occupancy	\$575.00 (50% due at booking)	\$575.00 (due 3 weeks before the retreat begins)

Once the deposit is paid, smaller, more regular payments can be arranged for the remaining amount on request by emailing Hayley, however full payment must be received by the final payment due date without exception.

### Cancellation Policy

Exceptions to our policy will not be made for any reason. We do not offer discounts, refunds or credit for arriving late or leaving early and any offered activities missed while on the retreat.

Internal Solutions Limited, Trading as 'Hayley Lowe' and Jenny Geelan Wellbeing offer no refunds for any reason, including weather, injury, or personal emergencies.

We are committed to providing a high quality retreat and have very limited spaces, therefore we expect to receive only firm bookings from intended guests. However, if a guest must cancel their reservation, our policy is as follows:

1. All deposits are non-refundable.
2. If you cancel between 30-90 days prior to the first day of the retreat you are registered for, and have paid the full amount, 100% of your final payment (excluding deposit) will be put in credit to be used with either Jenny or Hayley within a 12 month period of your original booking. Percentage returned is less the non-refundable deposit.
3. If you cancel within 30 days of the first day of your retreat 50% of your final payment balance will be put in credit to be used with either Jenny or Hayley within a 12 month period of your original booking, 50% of your final payment is forfeited. Percentage returned is less the non-refundable deposit.
4. If a guest cancels within 14 days of their retreat start date, their payment is forfeited in full.
5. All cancellations must be received in writing sent via email or registered mail.
6. Internal Solutions & Jenny Geelan Wellbeing are not responsible for expenses incurred in preparation for any cancelled trips, such as

airline tickets, or for costs incurred due to travel delays, flight cancellation or illness. **We strongly recommend all participants to obtain travel insurance with a trip cancellation policy which covers the individual.** Please check with your travel insurance company for more detailed information.

7. A retreat reservation is fully transferable to another female over the age of 18, for the same date and package.
8. Should Internal Solutions & Jenny Geelan Wellbeing need to reschedule the retreat for any reason another date will be provided and we will work with you individually to find a mutually agreeable solution should the date no longer be suitable.

## Liability Waiver and Assumption of Risk

**BY BOOKING YOUR PLACE ON THE RETREAT AND ELECTRONICALLY TICKING THAT YOU HAVE READ, UNDERSTOOD & AGREED TO THE LIABILITY WAIVER & ASSUMPTION OF RISK - THESE ARE THE TERMS YOU ARE BOUND BY.**

In consideration of the services of Internal Solutions Ltd, Jenny Geelan Wellbeing, their agents, owners, officers, volunteers, participants, employees, service suppliers and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as “the providers”), I hereby agree to release, indemnify, and discharge the providers on behalf of myself, personal representatives and estate as follows:

1. I acknowledge that travelling entails known and unanticipated risks which could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of some activities. My participation in all retreat activities is purely voluntary, and so I expressly agree to assume the risk of injury or damage while participating in all activities during my stay with the providers and agree these occurrences are not grounds for a refund or discount.
2. I certify that I have been strongly advised to take travel insurance to cover any injury or damage I may cause or suffer while participating on any of the retreat activities, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
3. I understand that weather, water, and conditions are beyond the control of the providers and its agents. Other natural elements such as reptiles, rodents, insects, and micro-organisms such as bacteria and viruses are also an inherent risk on an these retreats and are not grounds for a refund or discount.
4. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless the providers, its officers, employees and suppliers against all claims of losses, causes of action, damages or expenses of claim and against any costs including legal fees that may be incurred as a result of any such claims losses, damages or expenses whether valid or not, including any such claims which allege negligent acts or omissions of the providers.
5. Should the providers or anyone acting on their behalf, be required to incur attorney’s fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs.

I acknowledge that if anyone is hurt or property is damaged during my participation on a retreat, I may be found by a court of law to have waived my right to maintain a lawsuit against the providers on the basis of any claim from which I have released them herein. This is to certify that the providers, its employees & suppliers are released from any responsibility for any loss, mishap, accident, injury or death that may occur during my participation on a retreat.
