

**ORDINANCE NO. 19-251**

**AN ORDINANCE OF BOARD OF DIRECTORS OF THE BEAR VALLEY COMMUNITY SERVICES DISTRICT AMENDING DISTRICT CODE TITLE 1, CHAPTER 5, SECTION 10(C)(6) PERTAINING TO STANDING COMMITTEES OF THE BOARD**

The Bear Valley Community Services District Board of Directors ordains as follows:

**SECTION 1. Findings.** The Board of Directors finds as follows:

- A. Section 10 of Chapter 5 of Title 1 of the District Code establishes certain standing committees of the Board and generally confers upon the Board President the authority to annually appoint Board Members to serve on those committees.
- B. The Board desires to amend Section 1-5-10(C)(6) to remove the limitations on the President's authority to appoint Board Members to the Liaison Committee.
- C. This ordinance amends Section 1-5-10(C)(6) to achieve the above-stated purpose.


**SECTION 2. Amendment to District Code Chapter 1-5.** Section 10(C)(6) of Chapter 5 of Title 1 of the Bear Valley Community Services District Code is amended and restated as follows:

**“1-5-10(C): Designated Standing Committees; Duties:**

- 6. Liaison committee: Maintains a close, cooperative and communicative relationship between the Bear Valley Springs Association and the district, including reviewing programs, services and amenities related to parks and recreation.”

**SECTION 3. Severability.** If any section, subsection, sentence, clause, or phrase of this ordinance is for any reason held to be invalid or unconstitutional by a decision of any court of competent jurisdiction, such decision will not affect the validity of the remaining portions of this ordinance. The Board of Directors hereby declares that it would have passed this ordinance and each and every section, subsection, sentence, clause, or phrase not declared invalid or unconstitutional without regard to whether any portion of the ordinance would be subsequently declared invalid or unconstitutional.

**SECTION 4. Publication.** The Secretary of the Board of Directors is directed to cause this ordinance to be published in the manner required by law.




