- 3) Discuss Final Draft Disaster Preparedness Plan and six recommendations to be heard by the Public Safety Committee on Thursday April 21.
 - a) Mark Earley announced a probable tour of the Sheeptrail alternate egress route pending.
 - b) Greg Matheson to attend PSC meeting to hear comments and respond to questions. Other DPAC members encouraged to attend.
 - c) Greg Matheson provided an overview of the concept and process of the Plan and Recommendations
 - d) No discussion on the Plan or Quick Guide
 - i) Mark Earley/Greg Matheson reminded attendees that the Plan only incorporates existing infrastructure and procedures. Additional detail will be added as recommendations are implemented. Also, utilization of Zones was not included pending the official acceptance of a Zone map by the District.
 - e) Recommendations Discussion
 - i) Recommendation #1 Hazard Clearance of data/voice suppliers
 - (1) Suggestions made to add removal of tree overhangs on Bear Valley Road egress route
 - ii) Recommendation #2 Notification sirens
 - (1) Bill Malinen commented that the sirens were intended primarily for notification to people out of doors. Should not be only system
 - (2) Greg Matheson commented that all existing methods of notification would remain in addition to the sirens.
 - (3) Public attendee elaborated on additional in-person types of notification and community groups like CERT. The issue of liability by non BVCSD employees was mentioned.
 - iii) Recommendation #3 Adding redundant information system with portable radios
 - (1) Dick Brown provided an overview of the receiver only radio notification system along with an explanation of the Valley radio group. He stated the receivers could be purchased for

as little as ~\$25. They would need to be controlled by the DVCSD and the frequencies programmed into the units prior to distribution.

- iv) Recommendation #4 Adding signs on roads with no exit
 - (1) Public attendee mentioned that this issue has been raised before.

 - (1) Public attendee recommended adding a map of Refuge Points to the plan and to keep in mind horse and other trailers occupies more than one parking spot
- vi) Recommendation #6 Adding west end egress route(s)
