PLANNING COMMISSION meets each calendar quarter as determined by PC and as applications are received (weeknights @ 6:00 pm) at the Township Hall. It holds hearings when appropriate and reviews development plan and makes recommendations to the Townships Board with respect to the zone changes, special uses, and zoning ordinance amendments. The commission consist of five (5) members who are appointed by the Township Supervisor subject to approval by a majority vote of the members for the Township Board. An appointment to this Commission is a two (2) year term.

ZONING BOARD OF APPEALS meets as needed (usually on a weekday at 6:00 pm) at the Township Hall. The zoning board of appeals is authorized to grant dimension variances from the zoning ordinances and upon request may interpret questionable provisions of the zoning ordinance. This board consists of four members in total (3) members and one (1) alternate who are appointed by a majority vote of the Township Board. An appointment to this Board is a two (2) year term.

PARKS AND RECREATION COMMITTEE meets at the Township Hall on a monthly basis as determined by members of the committee. Their purpose is to promote the Cedar Creek Township Park and provide increasing recreational opportunities. This is an Advisory Committee.

BOARD OF REVIEW meetings take place at Township Hall and are set by State Statues in March, July, and December to hear protest of assessed and/ or taxable values of real and personal property to assure that all non-exempt property has been assessed at 50% of the true cash value and uniformly assessed with other properties in the classification and to correct clerical errors and omissions. This Board consists of four members in total (3) members and one (1) alternate who are appointed by the Township Board based on the Township's Supervisor's recommendation for a two (2) year term.
