Other features of the ORBCOMM ELD include advanced messaging capabilities that improve communication between drivers and office staff, the ability to design custom data entry forms and use form messages and text-to-speech functionality for safety. Dedicated online HOS and exceptions workspaces along with real-time HOS and duty graphs for drivers eliminate issues like unassigned miles with a few clicks. Built on an open, scalable platform, the ORBCOMM ELD also enables customers to easily add third-party applications, store and view documents, capture signatures and send high-resolution images for added efficiency.
