Academic Tuition (Per Student as follows)

Plan 1: Annually (Allows you the convenience of making a one-time tuition payment, due by July 15, 2019).

ANNUAL TUITION INCENTIVE
A \$200 PER STUDENT DISCOUNT WILL BE GIVEN FOR THOSE WHO PAY THEIR TOTAL TUITION BY JULY 15.

Plan 2: Monthly/10 Months (Allows you to make one payment per month, due by the 10th of each month, August 2019 through May 2020).

Plan 3: Monthly/12 Months (Allows you to make one payment per month, due by the 10th of each month, June 2019 through May 2020; in order to be eligible for this plan, the student must be registered no later than May 15, 2019).

A **Late Payment Fee** of \$25 will be charged if monthly payment is not received by the 10th of each month.

Tuition Assistance

Springwood School is approved by the Alabama Department of Revenue to partner with various Alabama Scholarship Granting Organizations (SGO). The SGO provides scholarships to eligible students as a result of the (2013) Alabama Accountability Act. For more information on applying for these scholarships, please check with the Springwood Admissions Office.

Springwood also has a need-based financial assistance program to provide financial aid to families who desire for their children to attend the School. In order to receive financial aid, a student must meet admission requirements and the family must complete a financial aid application with the most recently filed federal income tax return so that the family's adjusted gross income may be validated. Springwood uses a Financial Aid Calculator to guide decisions based upon family size and adjusted gross income. Any family may apply; however, all aid is awarded on the basis of financial need of the family, enrollment limits, and the availability of funding for the program. In the absence of extenuating circumstances, in order to receive financial aid, the total household income of the applicant family must not exceed \$95,000. Additionally, the maximum annual award will not exceed an amount equal to 85 percent of the School's published rate of tuition.
