By accepting this Privacy Policy and our Terms and Conditions of Use ("Terms"), you expressly consent to our use and disclosure of your personal information in the manner described in this Privacy Policy. This Privacy Policy is incorporated into and subject to the Terms and Conditions of Use (the "Terms").

Spirit App, LLC ("we", "us", "Spirit"), which owns and operates the getspirit.io website, the Spirit App Application, and related goods and services (collectively referred to as the "Services"), has created this privacy policy (the "Privacy Policy") as part of our commitment to helping our users better understand what information we collect about them and what we may do with that information. The following discloses our information gathering and dissemination practices for our Services.

By using the Services you agree to the following terms: We understand the concerns that you may have about your privacy and respect your right to protect your personal information while online. As part of the normal operation of our Service we, therefore, collect and, in some cases, may disclose information about you. Accordingly, by submitting your profile picture, and/or any personal information, you thereby waive any privacy expectations you have with respect to our use of your likeness or personal information provided to us in connection with the Services.

The Information We Collect and Method of Collection

As you use the Services the Internet protocol (IP) address of your computer, "cookies" and other standard tracking data to evaluate website traffic and usage patterns are collected. Such information is aggregated with tracking data from all users. Cookies are small packets of information sent by the Services through your browser to your computer. These cookies can be deleted or modified through your Internet browser settings. If you do not want your browser to accept cookies, you can turn them off in your browser's settings. If you choose to reject cookies you may be unable to utilize fully all of the Service's features and information. Such information is aggregated with tracking data from all users of the Services. To browse specific events at your Organization, you will be required to login to your

account with your user name and password. For purposes of this Privacy Policy, the term “Personally Identifiable Information” refers to any information that identifies or can be used to identify, contact, or locate the person to whom such information pertains.

If you order event tickets, make requests, e-mail us, or register to receive materials and information from us, you will be required to provide some or all of the following Personally Identifiable Information: name, address, e-mail address, telephone number, or credit/debit card information through a third party provider. You are required to review the terms and conditions, privacy policy and other relevant policies which may govern use of the third party’s services.

The Way We Use Information Collected Via the Website

We use the Personally Identifiable Information that you provide to us when using the Services. We share this information with the organization associated with your account. We do not share this information with other outside parties except to the extent necessary for the processing of credit/debit cards.

We use return e-mail addresses to answer the e-mails we receive from you. These e-mail addresses are also added to our mailing list database from which we send out our periodic newsletter for updates on new products, services and promotions. Any such communication from us will include information on how you may unsubscribe from future mailings from us.

We do not sell, rent or share Personally Identifiable Information with any outside third parties. We may send e-mails to you on behalf of third parties, but we will not share your Personally Identifiable Information with such third parties. Any such communication from us will include information on how you may unsubscribe from future mailings from us.

If you would like to receive our newsletter, as well as updates on our new products and services and promotions, you can register to receive such information through

the Services. Personally Identifiable Information that you submit in connection with this registration will only be used for this purpose. If you no longer wish to receive such information, we will provide you with the opportunity to opt-out. We will not share this information with outside parties.

We may use any e-mail addresses submitted through, or in connection with, our Services to inform you of changes to this Privacy Policy and the Terms. If you do not wish to receive such updates, we will provide you with the opportunity to opt-out. We may use Personally Identifiable Information that you submit via the Services to monitor or improve use the website or Services, to track traffic and usage patterns, to customize the advertising and content that you see on the Services, and to monitor compliance with the Terms.

We reserve the right to disclose the information collected by and through the Services, including your Personally Identifiable Information, as required by law and when we believe that such disclosure is necessary (i) to protect our rights, a third party's rights, or the rights of the public at large; or (ii) to comply with a judicial proceeding, subpoena, court order or other legal process served on Spirit. The disclosure of this information may be without notice to you.

We may share the Personally Identifiable Information collected through your use of the Services with our affiliates, related companies, and entities that may be involved in the operation of the Services. However, your Personally Identifiable Information will only be used as specified above.

Our Commitment to Data Security

To prevent unauthorized access, maintain data accuracy, and ensure the correct use of information, we have put in place industry standard physical, electronic, and managerial precautions to safeguard and secure the information we collect and manage via the Services. It is important to remember that whatever you transmit or disclose online can be unlawfully intercepted by third parties.

We use third party vendors to assist with the processing of credit/debit cards made through our Services. Please see the third party vendor's Privacy Policy with respect to its privacy practices.

Our Commitment to Children's Privacy

Protecting the privacy of children is important to us. We do not knowingly collect information from children under the age of 13. Service usage is not intended for children under the age of 13. If we learn that we have Personally Identifiable Information on someone under the age of 13, we will delete that information from our systems. We encourage parents and guardians to monitor children's online usage. Parental control protections, such as computer hardware, software or filtering services, are commercially available to limit the access to material that is harmful to minors.

The Services may contain external links to third party websites. We have no control over, and are not responsible for, the content of, or information gathered by these other websites. Any Personally Identifiable Information or other information collected by such third parties is subject to such third parties' privacy policies. The third party owners of these websites do not have access to the Personally Identifiable Information collected in connection with the Services.

Notification of Changes to Privacy Policy

We reserve the right, at any time and without notice, to add to, change, update or modify this Privacy Policy simply by posting such change, update, or modification on the Website. Any such change, update or modification will be effective immediately upon posting on the Website. If at any point we decide to use Personally Identifiable Information in a manner different from that stated at the time it was collected, we may notify you by way of an e-mail or some other means. Your continued use of the Services shall constitute your acceptance of such revised Privacy Policy. Since this Privacy Policy may change from time to time, you should review it periodically before you provide any additional Personally Identifiable Information through the Services.
