This category is designed to be attractive to golfers who are willing to give up the right to play during premium time, but still want unfettered access to the course during those times when they are permitted to play. Social Golf play is limited to Monday, Tuesday, Wednesday, Friday and Sunday after 1pm. There is no play on Thursday or Saturday for this category and Club tournament play is not permitted. Monthly dues are inclusive of ancillary fees (driving range and golf bag storage).

This category has no access to the Golf Course, but Social Dining Members can play as a Guest once a month.

Monthly dues are inclusive of ancillary fees (driving range and golf bag storage) *DOES NOT include assessments and applicable taxes on dues/assessments.*
