



## Our Privacy Commitment

The For Good Foundation is committed to protecting your personal information.

We do not sell, trade, or rent the names of our donors and supporters.

We abide by the following 10 fair information principles:

1. **Accountability** – We are responsible for your personal information under our control. If you have any concerns regarding our handling of your personal information, please do not hesitate to contact us at [privacy@theforgoodfoundation.ca](mailto:privacy@theforgoodfoundation.ca).
2. **Identifying Purposes** - We identify the purposes for which your personal information is being collected before or at the time we collect it. These purposes generally include administering your donation, fundraising, corresponding with you, providing information about the work we are doing and to comply with legal requirements.
3. **Consent** - We will obtain your consent to collect, use, or disclosure your personal information, except where otherwise permitted or required by law. Consent may be provided orally or in writing or may be implied, such as where you use our website, make a donation or continue to provide personal information to us in the context of our ongoing communication. In providing any personal information to us, whether through this website or otherwise, you consent to the collection, use and disclosure of that information in accordance with this Privacy Commitment.
4. **Limiting Collection** - The collection of your personal information is limited to the purposes for which we have identified to you.
5. **Limiting Use, Disclosure, and Retention** - Unless you otherwise consent or otherwise as required by law, your personal information can only be used or disclosed for the purposes for which we collect it, and we will only keep your personal information as long as required to serve those purposes.
6. **Accuracy** – We will keep your personal information accurate, complete, and up-to-date based on the information you provide to us to properly satisfy the purposes for which it is to be used. 7. **Safeguards** – We keep confidential and protect your personal information under our control with appropriate security relative to the sensitivity of your information, although most methods of communication are not fully secure. To the extent that we rely on third parties, to provide services for us that involve collecting and storing your personal information, such as our donation platform provider SimplyK, and SimplyK’s credit card processor, Stripe, we have taken all reasonable precautions to confirm that they maintain appropriate privacy and security measures pursuant to their own privacy policies.
