

# Mahana Privacy Notice

**Effective date: 10 January 2020**

This privacy notice is for people who use this Mahana website and for people who we communicate with for marketing purposes.

We respect your privacy and will treat your data in accordance with applicable law.

There is a separate privacy statement for people who use the Mahana platform and programs.

## **How we collect your personal data**

Your data is collected by Mahana in a few ways:

- Data you give directly
- Data we collect automatically when you use the website
- Business contact information we get from third parties

## **What personal data we collect and use**

Here is a list of the categories of personal data that are collected and used, with examples.

### **Contact details**

Your name, company, role, email address, telephone number, postal address, etc.

We also collect business contact information from third parties who manage relevant business contact databases.

### **Inquiry data**

Type of inquiry, text of inquiry

## **Data about your use of our website and emails**

IP address, unique identifiers, browser type and version, time zone and language, pages viewed

## **How and why we use your personal data**

### **Inquiries**

We use your contact details and inquiry details to respond to your inquiries. If you send a sales inquiry, we will add you as a business contact.

### **Marketing**

We communicate with business contacts (i.e. existing or potential customers) about relevant products or services.

We will not sell or lease your personal data to third parties. We do not directly market to Mahana platform clients.

### **Understanding usage and improving services**

Mahana records data and uses analytics tools to help analyze how users use the site.

## **How and why we share your personal data with third parties**

### **Research Partners**

We may share information with our research partners for particular projects or surveys. If you take part in such a project, you will be informed of these third parties in a separate or supplemental privacy notice.

### **Other**

We may also provide your information to third parties engaged by us to provide services to us, such as:

- professional advisers, including accountants, auditors, compliance consultants, legal advisers and tax advisers;
- fraud prevention agencies;
- courier companies;
- information technology providers, including providers of client relationship management systems and information security providers;
- insurance brokers; and
- data storage suppliers.
