Curriculum vitae (CV)

Professor Dr. Kirsten R. Müller-Vahl is a professor of psychiatry at the Department of Psychiatry, Socialpsychiatry and Psychotherapy at the Hannover Medical School (MHH), Germany. She is a specialist in both neurology and adult psychiatry and worked for many years in a specialized movement disorder clinic before she moved to the department of psychiatry in 1997. Since 1995 she is the

head of the Tourette outpatient clinic at MHH. Since then, she has seen more than 2000 patients with TS at all ages.

Her scientific work related to TS includes a large spectrum including RCTs using all kinds of treatments (from behavioural therapy to different pharmacotherapies including cannabis-based medicines, and DBS), neuroimaging and genetic studies as well as studies investigating different clinical aspects of the disease. In 1998 and 2005, she received research grants from the TAA, Inc. She was a full partner in the EU funded FP7 program EMTICS and a work package leader in the EUfunded interdisciplinary training network TS-EUROTRAIN. Currently, she is a collaborator in TIC Genetics, PI in two large IITs (ONLINE-TICS: Trial to Demonstrate the Efficacy and Safety of Internet-delivered Behavioral Treatment for Adults With Tic Disorders and CANNA-TICS: Cannabinoids in the Treatment of Tics), PI in "Study of ABX-1431 in Adult Patients With Tourette Syndrome or Chronic Motor Tic Disorder" and investigator in "D1AMOND: Ecopipam Tablets to Study Tourette's Syndrome in Children and Adolescents".

She published more than 130 PubMed indexed publications, a German language reference book on Tourette syndrome, is co-author in "Tourette syndrome" edited by D. Martino and J. Leckman and is editor of a German reference book on "Cannabis in Medicine". She is first author of the German guidelines for the treatment of tics published by the German Society for Neurology, first author of the "State of the art treatment guidelines" of the German Society of Psychiatry, Psychotherapy, Psychosomatic, and Neurology, first author of the ESSTS guidelines Part IV: DBS, as well as coauthor of the AAN practice guidelines on the treatment of tics in Tourette's and the TAA "Position Statement on the Use of Medical Cannabis and Cannabis-Based Medicines for Tourette Syndrome and Tic Disorders".

From a very early stage in my scientific education, I have been interested in Tourette syndrome, its complexity, its overlap between psychiatry, neurology and pediatrics, and the impact of the disease on the child and its family.

In 2009, I finished my PhD study "Tourette syndrome and co-morbidity - Diagnostic process and impact of psychosocial consequences, severity of tics, pharmacological treatment, and intelligence" (University of Copenhagen).

In 2014, I finished my medical specialization in pediatrics, and in 2017 my subspecialization in neuropsychiatry. I am currently working as a neuropsychiatrist at the pediatric department, Herlev University Hospital in Denmark and clinical associate professor at the University of Copenhagen.

Since 2017, I have had a combined research and clinical position, which has given me the opportunity to initiate several neuropsychiatric research projects at our department, among others on Tourette syndrome.

In 2008, while doing my PhD on Tourette syndrome, I attended a meeting on Tourette syndrome in Bari, Italy. This turned out to be the meeting, where ESSTS was resurrected and I feel privileged to have been able to see ESSTS growing and developing in the years thereafter. It was a great pleasure to host the ESSTS meeting "at home" in Copenhagen in 2018.

After all these years on the sidelines, I would like to become a more active part of the still developing and growing society. Dear ESSTS Members,

I am currently working as Postdoctoral Associate at the Department of Neurology, Yale University, USA. I am also affiliated with the Department of Neurology and the Department of Bioethics, Medical University of Warsaw, Poland.

I have attended ESSTS meetings since 2014 and became extremely interested in TS both scientifically and clinically. Since then I have been participating in several local and international projects aimed to investigate the pathophysiology and treatment of TS.

I have also been awarded grants that enabled me to gain more expertise abroad: in 2017 I visited for 6 months the TS Outpatient Clinic in Hannover Medical School Germany, led by Prof. Kirsten R. Müller-Vahl, world acclaimed specialized in TS, with whom I am closely co-working until now. While in Hannover, I was able to gain expertise in various clinical aspects of TS and participate in variety of scientific activities. Together with Prof. Müller-Vahl we have published eight articles dedicated to the treatment of TS with cannabinoids, DBS and pathophysiology of tics. We are now finishing the preparation of the new version of European Clinical Guidelines for Tourette Syndrome and Other Tic Disorders (Assessment and DBS Parts as well as Editorial).

I am also the co-author of the Polish Guidelines for the diagnosis and treatment of TS (Janik et al. 2018). Together with the supervisor of my PhD thesis dedicated to clinical aspects of TS, such as self-injury and dystonic tics, Prof. Piotr Janik, we have published eleven articles aimed to investigate the pathophysiology and treatment of TS.

In 2019, I have been awarded the Research Fellowship granted by the Kosciuszko Foundation and spent 3 months at the Yale University, working in the Lab of Prof. Michael Bloch and Prof. James Leckman. I have also been awarded the Clinical Fellowship of the European Academy of Neurology and gained experience in movement disorders in Department of Neurology, Medical University of Innsbruck, Austria (September-October 2018) as well as Joined Clinical Fellowship awarded by the Movement Disorders Society and the European Huntington's Disease Network (Department of Neurology, Ramon and Cajal Hospital, Madrid, Spain, November-December 2017).

For my accomplishments, I have been awarded the Scientific Award for the Young Scientist founded by the Journal "Polityka" (2019) as well as have been nominated to the Adam Rojszczak Prize founded by Foundation for Polish Science.
