## BUSINESS UPDATES

United Sign, here in Burnside, has responded to the COVID-19 medical supply shortages by making 10,000 face shields for New Brunswick healthcare workers! <http://unitedsign.ca/>

Parliament approved the Canada Emergency Wage Subsidy to provide a 75% wage subsidy to qualifying businesses for up to 12 weeks, retroactive to March 15th. Revenues must have dropped by a minimum of 30%, calculated either year-over-year or against January and February average revenue.

New changes to the Canada Emergency Response Benefit allow employees to earn up to \$1,000 per month while collecting CERB and extending the benefit to seasonal workers and those unable to find work as a result of COVID-19.
