ADMINISTRATIVE ACTIONS

Members approved the April minutes.

FISCAL SPONSORSHIP DECISION

Rahn recapped the Executive Committee's meeting with the PIC Board. Executive Committee Members shared with the PIC leaders the scope of the work the Compact is trying to do, namely advocating for sustainable urban education, a varied ecosystem of schools and quality behind every door. They also shared the current areas of focus we're working on.

Rachel summarized three options for fiscal sponsorship:

(a) The Compact could incorporate as a 501(c) 3 and contract with the PIC to keep a separate set of books and accounts for us ("fiscal agency")

(b) We could leave the PIC and find a new home, either independently or possibly with another fiscal sponsor

(c) We could enter a "comprehensive fiscal sponsorship" with the PIC

She reiterated the Executive Committee's recommendation to stay with the PIC and enter comprehensive fiscal sponsorship, as the other two options would be significantly more expensive in time and money.

The group shared both enthusiasm and concerns about continuing with the PIC. Most understood the PIC Board's desire to want to have some oversight of Compact work, since they are legally liable for it. Committee Members wanted to be sure Compact and PIC roles were clarified in the MOU. A motion was made and approved to sign the annual MOU and to check-in in six months to see how the relationship is progressing.

ACTION ITEMS

- Staff will collect signatures from Executive Committee for the MOU with the PIC.
- The Steering Committee will check-in on this matter at its December meeting.
