Terms of Payment

Client Contract

Your quote becomes an order only when this contract is drawn up, signed by both parties and a \$100 deposit (100% in the case the event is booked less than one (1) month in advance) is received. The advance deposit is paid to reserve your date and is NOT REFUNDABLE. Cakes are first come first serve and I only do a limited number of orders per week. However, if you need to change dates or move your event, please call and I will be happy to make accommodating arrangements at no charge. Deposits are required at the sole discretion of Love + Sugar.

Final Payment

50% of the total (less the \$100 deposit) is due three (3) months before the wedding date. The final balance is due one (1) month before the event date. If your cake is ordered less than one (1) month before the event date, the total amount is due immediately at contract signing and your order will not be placed until payment is received. I am happy to accept payments on the final contract price – however, all funds must be received 14 days prior to the event or your order will not be made. Orders canceled prior to the 14 day lockout date can be refunded for the balance paid LESS the \$100 deposit. Orders canceled after the 14 day lockout date will be refunded at only 50% of the total contract price.

Terms of the Agreement

Return Items

Please return any stands, plates, or other decor to Love + Sugar no later than ten (10) days after your event. A valid credit card number or cash deposit is required for your rented items in case of lost or damaged items.

Cake changes

Changes to your cake order: size, description, flavors, etc. will be accepted until 14 days prior to the event date. After that lockout date I cannot accept any changes. Please communicate ASAP if something changes.

Delivery and setup

Delivery and setup are required for all wedding cakes and for some multi-tiered special occasion cakes. Delivery is free* within a ten (10) mile radius of Love + Sugar. (*Set up charges may still apply.) All other deliveries are \$2 per mile one way. If you want to pick up your cake, please make

arrangements beforehand to set up a time. Cakes over two (2) tiers are not eligible for pick up. Please arrive on time to pick up your cakes. If you or your representative elects to pick up and set up the cake, you assume all liability and responsibility for the condition of the cake once it leaves our possession. We are not responsible for any damage to the cake after setup is complete. You are responsible for providing an appropriate and secure table and environment for the cake(s). Cakes are heavy and require a sturdy table, and optimal room temperature. If flowers are provided by an outside source, we will place them for an additional fee. You acknowledge that fresh flowers are not a food product, and may contain pesticides, insects, dirt, or other contaminants. Love + Sugar is not responsible for any damage for wedding cakes displayed outdoors.

Cancellation Policy

In the event of cancellation: Cakes canceled prior to the 14 day lockout date can be refunded for the balance paid LESS the \$100 deposit. Cakes canceled after the 14 day lockout date may be refunded 50% of the total contract price. In the event that something unexpected occurs to affect your scheduled event date – please contact me to discuss options. Communication is key, if you are up-front about any issues about your date I will work hard to accommodate you. I understand things can come up that are out of your control.

My Guarantee

I promise to do everything within my control to deliver a cake that exceeds your expectations. I will work with you on every level to make sure you are completely satisfied and happy with your cake. Please note that colors and design of actual cake may vary slightly from hand drawn or computer mock-up due to the nature of digital and edible components.

Anniversary Cake

On the one (1) year anniversary of your wedding I will provide you with a six (6) inch two (2) layer cake in Vanilla or Chocolate with Very Vanilla filling and white buttercream. Option: substituting flavors may be allowed for a small fee. It is your responsibility to contact me two (2) weeks before to confirm your Anniversary cake. A \$500 minimum Wedding cake order is required to receive an anniversary cake

Disclaimer

In the case of an emergency or an error in your cake delivery, please contact me immediately so I can fix the issue right away! If you are unhappy with your cake for any reason, please call me the day of your event and explain the situation. In the rare case that you are unhappy with your cake and would like a refund, you must call the day of your event so your cake can be returned. Without proof that you are indeed unhappy with the product and will not be using it for your event, I will be unable to refund any portion of your payment. This is necessary to prevent the very rare case of, "If we complain, we'll get a free cake" issue. I am dedicated to satisfying your cake requirements. Buyer pays all bank fees related to NSF methods of payment.
