**FOOD SHELTER AND REHABILITATION PROGRAM: THE CITY MISSION PROVIDED FOR OVER 441 UNDUPLICATED MEN, WOMEN AND CHILDREN. THE COMBINED TOTAL REPRESENTS 32,986 BED NIGHTS OF SHELTER, PROVIDED THROUGHOUT THE YEAR. THE FOOD SERVICE PROGRAM SERVED 113,061 FREE MEALS AND 29% OF THOSE MEALS WERE SERVED TO NONRESIDENT HOMELESS AND NEAR-HOMELESS GUESTS. OUR LONG-TERM HOMELESS REHABILITATION PROGRAMS PROVIDE MEN, WOMEN AND CHILDREN WITH HEALTHCARE, CASE MANAGEMENT, COUNSELING, EDUCATIONAL, EMPLOYMENT, LEGAL AND SPIRITUAL DEVELOPMENT SERVICES TO ENCOURAGE THEM TO CHANGE AND EMPOWER THEM TO BE PRODUCTIVE MEMBERS OF SOCIETY. OUR SAMARITAN SERVICE CENTER DISTRIBUTED OVER 2,511 FOOD BAGS, 6,485 PIECES OF FURNITURE, 11,141 PIECES OF CLOTHING AND HOUSEHOLD ITEMS TO THOSE IN NEED IN OUR COMMUNITY. WE PROVIDED START UP FURNITURE TO ELIGIBLE RESIDENTS UPON THEIR DEPARTURE FROM THE MISSION.
