A. TULSA IRONMAN TRIATHLON 2020

<u>Background Information:</u> Ironman Triathlon will be coming to Tulsa in May 2020. Ray Hoyt, President of the Tulsa Convention and Visitors Bureau & Tulsa Sports Commission, is requesting exclusive use of the River Parks east bank trail from 11th to 71st Street on May 31st for the running portion of this multi-sport endurance race.

B. FLOOD DAMAGE REPORT AND AUTHORIZATION FOR USE OF CONTINGENCY FUNDS

<u>Background Information</u>: Authorization is requested for staff to use up to \$100,000 from the Authority's Contingency Fund to front-end costs for extensive clean up and repairs needed throughout the park due to the recent Arkansas River flood event, as well as damage from severe storms of May 25–26. Tulsa is among the counties included in a federal disasater declaration, allowing River Parks Authority to be eligible for federal and state reimbursement of up to 87% of the mitigation expense.

<u>Background Information</u>: Discussion and possible vote to approve proposed amendment to City of Tulsa Parks ordinance, requiring all dogs in parks to be on a leash, and repealing the option to allow a dog to be off-leash if it is in "immediate control of its handler."
