Collection of personal information

Personal data that we process

Stichting Sociale Bedrijven Dagen processes your personal data if you make use of our services, and/or because you provide us with these data yourself.

An overview of the personal data that we process:

- First and last name
- Telephone number
- Email address
- Year and field of study
- IBAN/Bank account number

The purpose with which we process personal data

Stichting Sociale Bedrijven Dagen processes your personal data for the following purposes:

- Handling your transaction
- Improving the quality of our services (e.g. matching your profile to a participating company in any of the sessions)
- Being able to call or email you in case this is necessary to carry out our services
- Being able to inform you about important details of and/or changes to our services

How long do we save personal data?

Stichting Sociale Bedrijven Dagen does not save your personal data any longer than strictly needed to realise the purposes for which it is collected. We maintain a retention period of 3 months after the Social Sciences Career Event for all personal data collected.

Sharing personal data with a third-party

Stichting Sociale Bedrijven Dagen shares your personal data with a third-party in case it is necessary for selection. This data entails your year - and field of study and your language proficiency. We reserve the right to send your personal data to third parties where explicitly obliged by law.

Personal data of minors

Our website and/or service does not intend to collect data of website users younger than 16 years, unless they have been given permission by a parent or guardian. We cannot monitor, however, whether a website user is older than 16. We advise parents to be involved with the online activities of their children, to prevent the collection of personal data of children without parental consent. In case you are convinced that we collected personal data of a minor without that permission, please get in contact with us via secretary@sctiu.nl. We will then delete this data.

Check, alter or delete personal data

You have the right to check, alter and/or delete your personal data. Besides that, you have the right to withdraw – or object against your earlier given permission for the processing of your personal data by Stichting Social Bedrijven Dagen. Additionally, you have the right of data portability. This means that you can file a request to share – in a file – all the personal data we possess of you, to you, someone else, or an organization named by you.

You can file any request of the sort to secretary@sctiu.nl.

In order to make sure that you are in fact the person filing the request, we ask you to include a copy of your identity card in the request. Make sure to anonymize; the photo, MRZ (machine readable zone, the strip with numbers at the bottom of the card), passport number and citizen service/personal number (in the Netherlands: BSN). We will react within four weeks, as fast as possible.

Stichting Sociale Bedrijven Dagen would also like to make you aware of the possibility to file a complaint which you can send to the national supervisory authority, "de Autoriteit Persoonsgegevens". You can do so via the following link:

How we protect personal data

Stichting Social Bedrijven Dagen takes the protection of your personal data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification. Reporting obligation data leaks

Stichting Sociale Bedrijven Dagen is obligated to report any major data leaks. A data leak is a confirmed incident in which sensitive, confidential or otherwise protected data has been accessed and/or disclosed in an unauthorized way. If a data leak occurs, our organization is

obliged to notify the involved parties. This will be done within 72 hours. After a data leak, Stichting Sociale Bedrijven Dagen will investigate where the leak could have occurred and how a similar leak in the future can be prevented. Automated decision-making

Stichting Sociale Bedrijven Dagen does not make any decisions about matters that can have (significant) impact for individuals based on automated processing operations. This concerns decisions that are being made by computer programs and/or systems, without the interference of a human being (like a board member of Stichting Sociale Bedrijven Dagen).

Cookies, or similar techniques we use.

Stichting Sociale Bedrijven Dagen uses technical and functional cookies, as well as analytical cookies that do not violate your privacy. Cookies are small text files that get saved on your computer, tablet or smartphone the first time you visit our website. The cookies we use are necessary for the technical operation and the user-friendliness of our website. They ensure that the website works as it should and remember your preference settings. If you object to the use of cookies, you can set your browser settings in such a way that it does not save cookies anymore. Next to that, you can delete all previously saved information via the settings of your browser.
