Non-Resident Members may not participate in the Club reciprocal program or play in Golf Committee run events. Non-Resident Members may reserve starting times one week in advance on weekends and holidays and two weeks in advance on weekdays. Guests are welcomed with payment of appropriate golf fees. Pool privileges are available at guest rates. Non-Resident Members are permitted to attend Club social events as well as use the dining facility with no limitations. Additional Information

Dues: Dues are paid by all members based upon their membership category and are billed either in full for our fiscal year, May 1 through April 30, or monthly. Those paying monthly will be billed in twelve installments.

Mortgage Fund: The mortgage fee is paid by all membership categories except House, Junior Golf, Twilight Golf, and Non-resident Golf. Mortgage fees charged to members are reserved for the payment of debt service only. The mortgage fee may be paid in full or billed in twelve installments.

Food Minimum: A monthly food minimum that includes food and non-alcoholic beverage purchases applies to all categories of membership except Young Professional Golf, Junior Golf, Twilight Golf, and Non-resident Golf. Reduced minimums for single members are available. An 18% gratuity and 6% sales tax are added to all applicable food and beverage charges. The gratuity and sales tax do not apply toward your minimum. The monthly minimum is charged to your account one-month in advance.

There is an application fee (equal to 4 months dues at the discounted rate) that will act as a deposit on your membership dues. Deposits are due upon submission of this application. Any member wishing to resign prior to two years, will be responsible for any remaining dues and fees. Exceptions may be made for those relocating more than 75 miles from the club.

The undersigned has received a copy of the Bylaws of CCC and its House and Course Rules and Regulations as well as information about the financial obligations of membership.

If this application is accepted, and the applicant is admitted in accordance with the formal admission procedures of the Club, the undersigned agrees to observe and be bound by the Bylaws and the House and Course Rules and Regulations of the Club in effect which may be updated from time to time. The undersigned agrees to maintain a current valid credit card on file with the Club at all times, and hereby authorizes the Club to charge such credit card for any amounts owed to the Club, including amounts reflected on monthly invoices, that are more than Forty Five (45) days past due. Should legal action be required to collect amounts due, I the undersigned will reimburse CCC for its reasonable attorney's fees and other costs of collection. Any unpaid amounts will bear interest and be subject to late fees in accordance with CCC policy.

If the undersigned is suspended from CCC for any reason, including non-payment of dues, he/she will forfeit all future dues credits.
