## Agreement

Please review the following important information. We require your consent upon check-in for all pet services we offer. Your signature confirms that you have read and agreed to our published information below:

I understand and agree to the following...

1. Doggie Diva's Bed Bark & Beyond, LLC agrees to exercise due and reasonable care, and to keep the kennel premises sanitary and properly enclosed. The boarding pet is to be housed in clean, safe quarters, and to be fed properly and exercised regularly. Fresh water, food, bedding, and toys are available for all our guests at all times. You are more than welcome to bring any of your own items for your pet's stay.
2. Owner represents that he/she is the owner of the pet, or has been authorized by the owner of the pet to enter into this contract as the owner's agent. Owner agrees to pay the boarding rate and for all services effective on the date the pet checks into our kennel. Owner is responsible for their own pet physically, financially, in regard to their health, injury, or otherwise, even if your pet may not be at fault.
3. Doggie Diva's Bed Bark & Beyond, LLC has relied on the information you have provided that your pet is in good health, is in compliance with our health and required vaccination standards, does not have any communicable conditions, and has not harmed or demonstrated aggressive or threatening behaviors towards any human being and/or another animal. We reserve the right to refuse admittance of any pet that shows signs of illness or aggression or does not meet vaccine requirements.
4. I understand that even though my pet is vaccinated for the most common viral diseases, this in no way guarantees that my pet cannot contract a different pathogen that can cause a problem such as "kennel cough". Also, some pets may develop loose stools or diarrhea during their stay. This can be caused by change of environment, upset stomach, change of diet, or a virus that vaccines are not able to protect against. If any of these problems occur, I agree that Doggie Diva's Bed Bark & Beyond, LLC is not to blame and agree to treat the problem at my expense.
5. All pets entering our kennel must be clean and flea free. Please be sure that your pets are current for flea and heartworm medications prior to arriving for boarding. If upon boarding, this is not the case, we will immediately administer a flea dip bath at your expense. This is not an optional item.
6. Doggie Diva's Bed Bark & Beyond, LLC is not responsible for the loss or damage of any personal items or belongings (bedding, toys, collars, etc) provided by owner for pet while the pet is boarded.
7. You grant permission to Doggie Diva's Bed Bark & Beyond, LLC owners, employees, contractors and/or agents to take any and all action necessary to secure the well-being and health of your pets, including any medical attention deemed necessary. If your pet becomes ill, or if the state of the animal's health otherwise requires medical attention, we have the sole discretion to provide first-aid or engage the services of a veterinarian of our choosing. All veterinarian expenses shall be 100% payable in full by you the owner or agent. You agree to hold Doggie Diva's Bed Bark & Beyond, LLC, our staff, our clients, and our clients' pets harmless and agree to pay for services provided to your pet.

8. Doggie Diva's Bed Bark & Beyond, LLC assumes no liability in the event of loss or damage to your pet as a result of disease, escape, theft, fire, injury to persons, other pets or property, as due diligence and care are exercised at all times. Owner also agrees to be solely responsible for any and all acts of behavior of said pet while it is in the care of the kennel, to include payment of costs for injury to staff or other animals, or damage to facility caused by pet.

9. You agree to release and hold harmless Doggie Diva's Bed Bark & Beyond, LLC, it's owners, employees, agents or otherwise from any and all loss, liability, claims, expenses, demands, causes of action, suits, rights, and entitlements of any kind, whether known or unknown, suspected or unsuspected, relating in any way to the services provided herein, including without limitation injury, death, sickness, or damage the pet may suffer during or after participating in any services provided. You agree to indemnify Doggie Diva's Bed Bark & Beyond, LLC for any and all loss, liability, claims, expenses, demands, causes of action, suits, rights and entitlements of any kind caused by your pet during the course of their stay at our kennel, including without limitation, legal costs and attorney fees.

10. Owner understands that if your pet is not picked up within (7) calendar days after the pet is scheduled for pick-up, pet shall be deemed abandoned. Doggie Diva's Bed Bark & Beyond, LLC then has the right to place pet with a new owner or local animal shelter. Owner shall remain liable for all boarding fees.

11. Doggie Diva's Bed Bark & Beyond, LLC charges a daily rate for boarding. You are charged for the 1st day regardless of time of check-in. You will not be charged any additional fees for the last day if you pick up by 11am. If you request a late pickup on the last day, you will be charged an additional \$20.00 per dog (our full daycare rate).

12. When booking, a credit card must be put on file in order to hold the reservation. We have a secure system where your data is safe. No charges will be made to your card if a (48) hour cancellation notice is given. If a (48) hour cancellation notice is not given, you will be charged 50% of your total reservation fee. If you are unwilling to place a credit card on file, payment for the reservation must be paid in full at the time of booking.

13. Our boarding pick-up and drop-off times are 9:00AM-11:00AM and 5:30PM-8:00PM. If these times do not work for you, our doggie taxi service can be utilized at our current rates. These times are utilized to let our staff give sole attention to care for your pet during the other hours of the day.

14. It is understood by Doggie Diva's Bed Bark & Beyond, LLC and owner that all provisions of this agreement shall be binding upon both parties for this visit and for all subsequent visits, unless requested to be terminated by either party. I have read and understand this agreement and I agree to accept all the terms, conditions, and statements. The policies and terms of the agreement can change at any time with notification.
